For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, ScheduledTribes, Other Backward Classes and Economically Weaker Section, necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note:- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates belonging to Other Backward Classes included in this list are required to produce Non Creamy Layer Certificate as per G.O.(P) No.81/2009/SC/STDD dated 26.09.2009, candidates belonging to SC/ST are required to produce Community Certificate in Form III or Digitally Signed issued by the Revenue Authority not below the rank of Thahilsdar and candidates belonging to Economically Weaker Section are required to produce EWS Certificate vide G.O(MS) No.5/2020 P&EA dated 04.03.2020 issued by the concerned authority at the time of OTR verification.

Note :- (7) Copy of answer scripts of the OMR Test held on **19-04-2024** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
