For the purpose of satisfying rules of reservation of appointments to Scheduled Castes, Scheduled tribes, Other Backward Classes (and other reserved categories if any) necessary supplementary lists is prepared by including sufficient number of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) Candidates included in the Short List should be present and produce in person the original documents for One Time Verification and Interview. **Date,time and Venue of both will be intimated in due course.**

(5) The Register number of those candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the Short List without further notice.

Note :- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (7) Candidates belonging Other Backward Classes included in this Short list are required to produce Non Creamy Layer Certificate as per G.O.(P) No.81/2009/SC/STDD dated 26.09.2009, candidates belonging to SC/ST are required to produce Community Certificate in Form III or Digitally Signed issued by the Revenue Authority not below the rank of Thahilsdar and candidates belonging to Economically Weaker Section are required to produce EWS Certificate vide G.O(MS) No.2/2020 P&ARD dated 12.02.2020 issued by the concerned authority at the time of OTR verification.

Note :- (8) Copy of answer scripts of the **OMR Test** held on **20-06-2024** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. As per Notification **No : ER3-3/3/2024.- KPSC** Dated: **26/09/2024** of the Secretary ,KPSC,Thiruvananthapuram , no answer scripts are invalidated for the above post . .
