Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidate included in the Short List is required to produce Non Creamy Layer Certificate as per G.O(P)No.81/2009/SCSTDD dated 26/09/2009 issued by Village officer and Medical certificate in the prescribed form as per Gazette Notification obtained from a Medical officer not below the rank of a Civil Surgeon along with other documents at the time of OTR verification.

Note :- (7) Copy of answer scripts of the OMR Test held on 29/11/2023 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answer scripts are invalidated as per Notification No.ER7-3/3/2024/EW dtd:04/03/2024.
