Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates included in the Short List are required to produce Non Creamy Layer Certificate as per GO(P) No.81/09/SCSTDD dated 26.09.2009 or that obtained through e-district portal in the format prescribed in GO(Rt) No.3942/2018/RD dated 24.09.2018 issued by the Revenue authority at the time of OTR Verification of original documents.

Note :- (7) Copy of answer scripts of the OMR Test held on **29-06-2024** will be issued to those candidates who, apply for the same remitting the prescribed fee after publication of the Ranked List.
