A period of 15 (fifteen) days time to apply for the image and tabulation sheet of answer sheets will be allowed to the candidates with effect from the date on which the Ranked List is uploaded in the website of the Commission (ie, on or before **13.01.2025**). Application submitted in any other manner (ie, via Email/Tappal/Direct) will not be considered. A copy of the answer sheet will be issued only once to a candidate. Copies of answer sheets invalidated due to any defect will not be issued.

NOTE (2):- The entries put in column (10) are based on the Communities specified by the candidates in their Application Forms and proved by them with necessary documents. The candidates whose Communities has not been correctly noted in the Ranked List as proved by them in their Application should intimate the fact to the Deputy Secretary (Examinations) - I, Kerala Public Service Commission, Thiruvananthapuram - 695004 within one month from the Date of publication of the Ranked List to get the benefit of reservation to which they are entitled to. In the absence of timely information regarding discrepancies, if any, the candidate will be advised as incorporated in the Ranked List.

After the publication of Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of vacancy, based on which he/she is to be advised
