The following is the list of candidates for selection to the post of **BEAT FOREST OFFICER (FIRST NCA - HINDU NADAR)** (Cat.No.563/2022) on Rs.20000-45800/-(PR) in **FOREST DEPARTMENT** in Ernakulam District , found suitable by the Commission and arranged in the order of merit on the basis of **OMR Test** held on **09.05.2023** , **Endurance Test** held on **18.11.2023** and **Physical Measurement and Physical Efficiency Test** held on **15.10.2024 to 21.10.2024**. This **NCA Ranked List** is brought into force with effect from **02.12.2024** and will be valid till the candidates are advised and appointed against the vacancy kept unfilled due to the paucity of candidates belonging to **Hindu Nadar** community during the currency of the **Mother Ranked list published on 17.03.2020 (Cat.No. 582/2017)** for the post.

**NOTE (1) :-** According to the existing procedure, revaluation of Answer Script is not allowed. But Answer Scripts will be rechecked if the candidates apply through their One Time Registration profile from the Commission's official Website [www.keralapsc.gov.in](http://www.keralapsc.gov.in) by remitting the prescribed fee of **Rs. 85/- (Rupees Eighty Five Only)**. The fee can be remitted by e-payment through the portal. Applications submitted in any other manner will not be considered. A period of **15(Fifteen) days** time to apply for rechecking of Answer Scripts will be allowed to candidates with effect from the date on which the Ranked list is uploaded in the website of the Commission ie., on or before **25.12.2024**. Rechecking of invalidated answer scripts due to any defects will not be considered. Application for Rechecking received after the stipulated time will not be entertained and Fee once remitted will not be refunded. Applications submitted through email/by post/ in person will not be considered.

**NOTE (2) :-** Candidates who wish to obtain a photocopy of their OMR Answer Sheets (Part A & Part B) relating to this selection shall submit online application through their One Time Registration profile from the official website of the Commission [www.keralapsc.gov.in](http://www.keralapsc.gov.in) by remitting the prescribed fee of **Rs.335/- (Rupees Three Hundred and Thirty Five only)** via e payment mode available in the portal. A period of **15 (Fifteen) days** time to apply for photocopy of OMR sheets will be allowed to candidates with effect from the date on which the Ranked list uploaded in the website of the Commission. A copy of an answer sheet will be issued only once to a candidate. Copies of OMR answer sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so. The last date for receipt of applications is **25.12.2024**. Applications received after the prescribed date will not be entertained. Applications submitted through email/by post/in person will not be considered.

**NOTE (3) :-**The entries put in column (5) are based on the Communities specified by the candidate in their Application forms and proved by them with necessary documents. The candidate whose Communities have not been correctly noted in the Ranked List as proved by them in their Application should intimate the fact to the District Officer, Kerala Public Service Commission, District Office, Ernakulam - 682 016 within one month from the Date of publication of the Ranked List to get the benefit of Reservation to which they are entitled to. In the absence of timely information regarding discrepancies if any, the candidate will be advised as incorporated in the Ranked List.

**NOTE (4) :-** Candidates who wish to relinquish their claim for advise from the Ranked list shall submit an application in the format prescribed by the Commission to the District Officer, Kerala Public Service Commission District Office, Ernakulam- 682016. The format is available in the official website of the commission. Those who do not submit the relinquishment application in the format prescribed by the commission will not be honoured under any circumstances. The request for relinquishment in the prescribed format should be duly attested by a Gazetted Officer of State/ Central Government with Signature, Name, Designation and Office Seal along with a notarized affidavit and a self attested copy of an ID proof bearing photograph as enlisted in the general conditions. The request for relinquishment along with the notarized affidavit and a self attested copy of an ID proof received within 15 days from the date of publication of Ranked List in the official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalization of the Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised.

**NOTE (5) :-** Since a common written test/ OMR test with common candidates was conducted for this post, the marks awarded to the candidates included in the ranked list and mark of OMR test relating to all candidates appeared for the test will be published only after the publication of entire Ranked lists which will be finalized on the basis of common test. The result of rechecking of OMR answer scripts will be intimated in due course. But photocopy of OMR answer scripts will be issued only after the publication of the Ranked lists for all the posts finalized on the basis of the Common test.

**NOTE (6) :-**The A part and B part of OMR scripts will be destroyed after completing 6 months period from the date of finalisation of the last Ranked list included in the common test.
