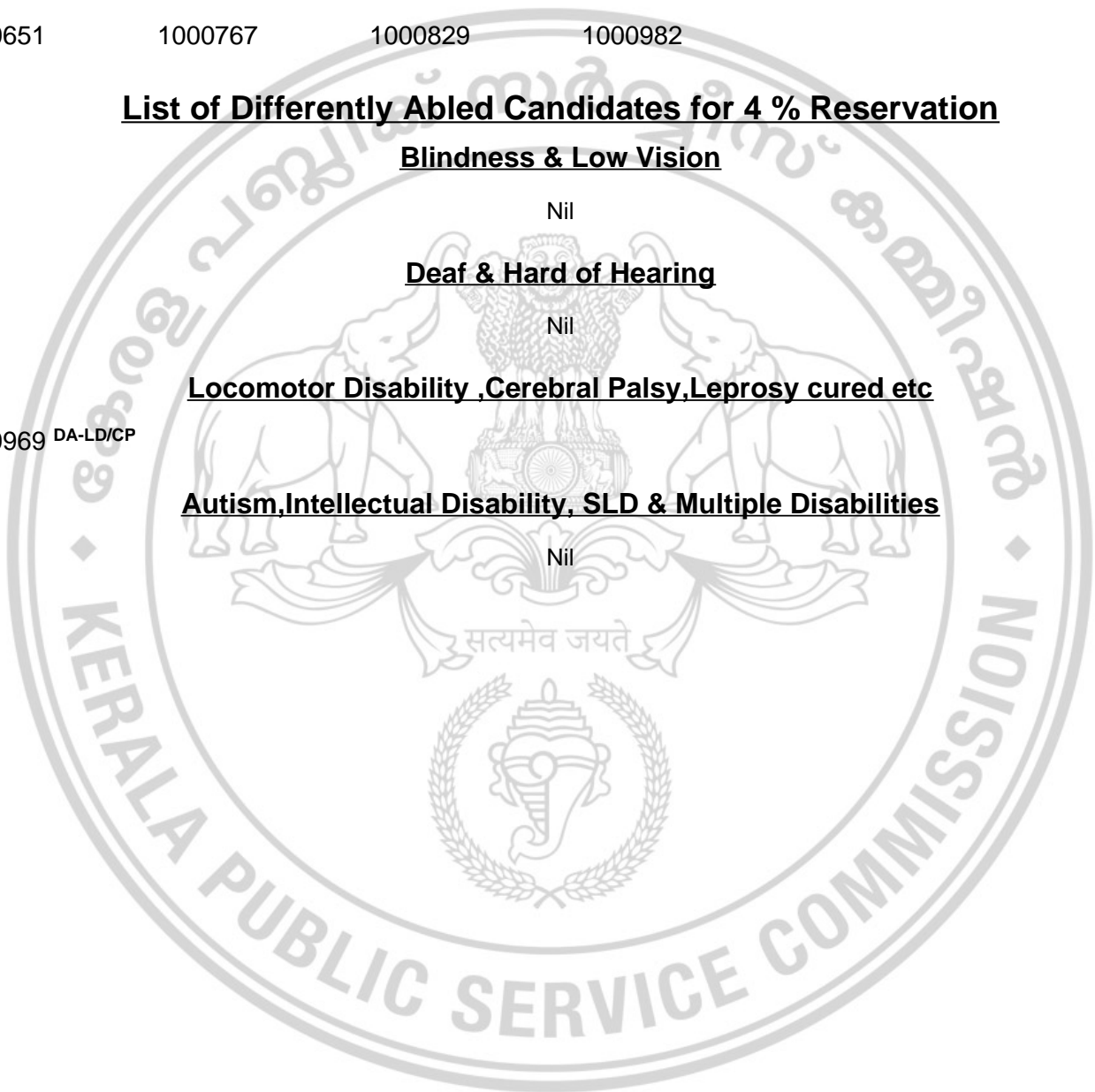

Note :- (3) 11 (ELEVEN) candidates who have secured top most marks in the OMR Examination are included in the Main List of the Short List . The marks secured by the last candidate in the Main List is **33.33 (thirty three(point) three three)**. For the purpose of satisfying the rules of reservation of appointment Scheduled Castes, Scheduled Tribes, Other Backward Classes (and other reserved categories if any) necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) Candidates included in the Short List should present and produce in person the original documents for One Time Verification and interview. **Date,time and Venue of OTR Verification and Interview will be intimated in due course.**

Note :- (5) Candidates belonging to Other Backward Classes included in the Short List are required to produce a Non Creamy Layer Certificate as per G.O.(P) No. 81/2009/SCSTDD dated 26.09.2009 ,SC/ST candidates are required to produce a Community Certificate in Form III or digitally signed certificate issued by the Revenue Authority not below the rank of Tahsildar & EWS Certificate in case of candidates having EWS reservation at the time of OTR Verification.

Note :- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (7) Copy of answer scripts of the OMR Test held on **19-07.2024** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No : ER7-2/7/2024 -KPSC dtd 09/09/2024.
