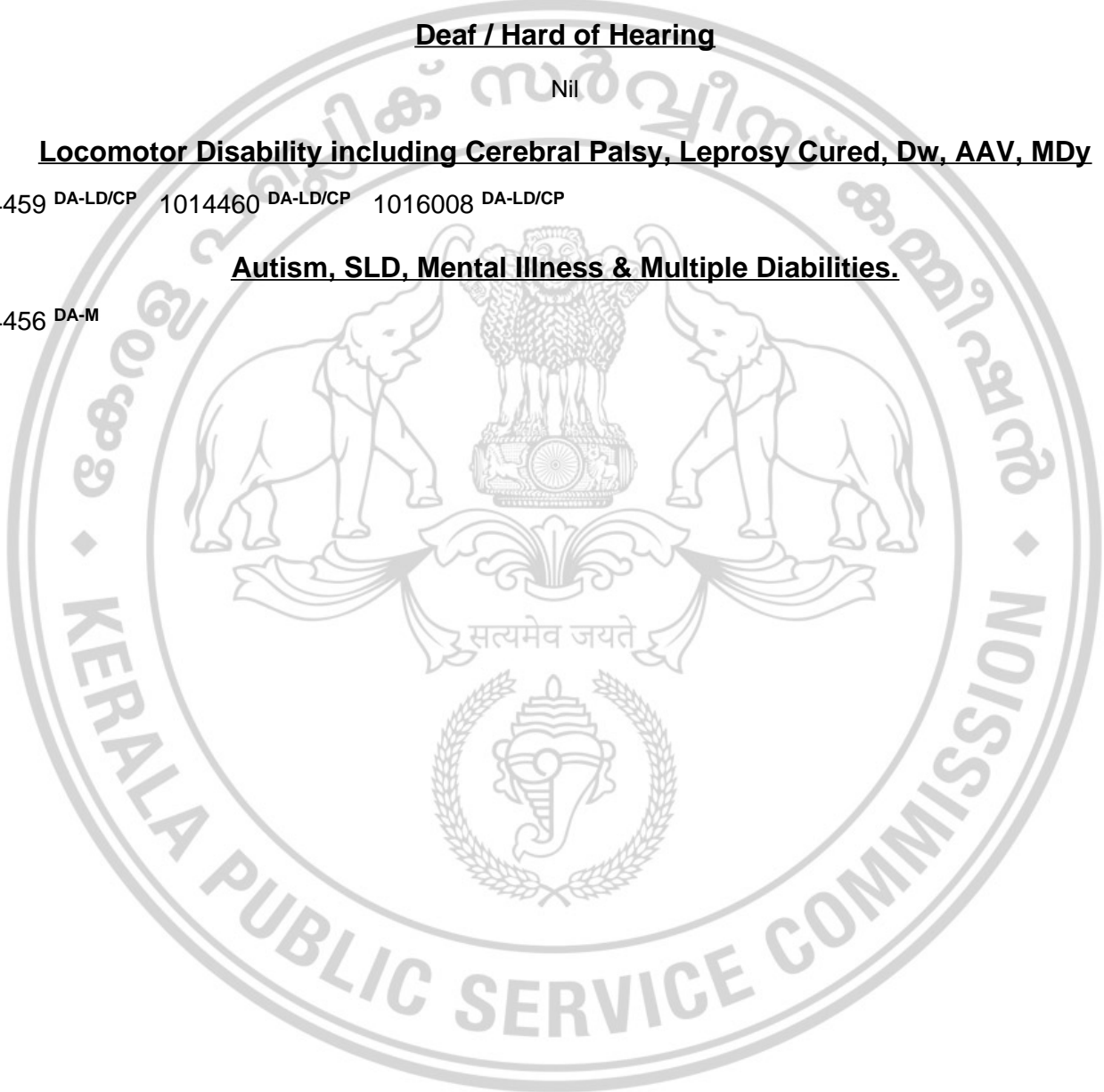

Note :- (2) The Short list has been prepared by including the requisite number of candidates in the Main List who have secured top marks in the Common Main OMR Test based on the details furnished by the candidate in the Application and subsequent claim, if any, will not be entertained at any stage.

Note :- (3) **205 (Two Hundred and Five)** candidates who have secured top marks in the OMR Examination are included in the Main List of this Short List. The marks secured by the last candidate in the Main List is **39 (Thirty Nine)** marks. For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes and Economically Weaker Section Category, if any necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) Candidates included in the Short List should be present in person for **OTR Verification and Interview. Date, Time and Venue of OTR Verification and Interview will be intimated through SMS, Profile Message and through Print and Electronic Media. The Short Listed candidates should download their Admission Tickets for the Interview from their OTR Profiles login on to the Official Website - www.keralapsc.gov.in of the Kerala Public Service Commission and appear for the Interview with necessary documents.**

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be incorporated in the Ranked List to be published for the post.

Note :- (6) Candidates included in the Short List who belong to Other Backward Classes are required to produce Non-Creamy Layer Certificate issued by Village Officer as per GO(P)No.81/09/SCSTDD dtd 26.09.2009, SC/ST candidates are required to produced Community Certificate issued under Rule 4 of Kerala (SC/ST) Regulations of issue of Community Certificates Rules 2002 by the Revenue authority not below the Rank of Thahasildar and candidates claiming reservation under EWS Category are required to produce EWS Certificate issued by Village Officer as per GO(MS)No.2/2020/P&ARD dtd 12.02.2020 along with other documents at the time of OTR Verification.

Note :- (7) Copy of answer scripts of the OMR Test held on **20.07.2024** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
