Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Copy of answer scripts of the OMR Test held on **13-08-2024** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answer scripts of candidates is invalidated as per Notification No : ER 7-2/9/2024-KPSC dated 05-11-2024.
