CHAPTER-I

CONSTITUTIONAL POSITION OF THE COMMISSION

The Public Service Commission is a body constituted under the provisions from Article 315 to 323 of the Constitution of India. The provisions regarding the Union Public Service Commission and other State Public Service Commission have been laid down in Chapter II of part XIV of the Constitution.

The Constitution empowers the Commission to deal with the matters relating to the services and enable them to discharge their duties in a fair and impartial manner free from influence from any quarter. The Chairman and Members of the Commission are appointed by the Governor of the State .

The Composition of the Commission is such that as nearly as one half of members of it shall be persons who on the date of their appointment have at least 10 years of service under the Government. The Chairman or any other member of the Commission can hold office for a period of six years or till he attains the age of 62 years whichever is earlier. On the expiry of the term, the Chairman or any other Member of a state Public Service Commossion shall be eligible for appointment as the chairman or any other member of the Union Public Service Commission or as the Chairman of any other State Public Service Commission, but not for any other employment either under the Govt.of India or under the Govt.of a state. The Chairman or any other Member of the Commission can be removed from the office only by the President of India in accordance with the procedure laid down in the Constitution. The conditions of service of the Chairman or a Member once appointed cannot be varied to his disadvantage. The expenses connected with the Public Service Commission are not voted but are charged on the Consolidated Fund of State.

<u>Details of amendments made to the Kerala Public Service Commission</u> (<u>Composition and Conditions of Service of Members and Staff) Regulations</u>

Regulation 7 of the Kerala Public Service Commission (Composition and Conditions of Service of Members and Staff) Regulations,1957 provides for the conditions regarding pension to the Chairman and Members of the Commission. As per G.O. (MS.) No.274/12/GAD dated 11.10.2012 the Government have revised the

pension of the Ex-chairman and Members of the Kerala Public Service Commission which resulted in reduction of pension up to 21%. The aggrieved persons filed WP(C)No.3081/2013 before the Hon'ble High Court of Kerala challenging the said oreder and the Hon'ble Court held that the said order is arbitrary and discriminatory and quashed it to the extend it fixed the pension in the case of Chairman and Members who are appointed from outside are concerned at reduced rate of their salary. The Hon'ble High Court also directed the Government to pass fresh orders taking into consideration of the progressive enhancement that was being effected from time to time since the year 1977. Hence, it has been decided to amend the Kerala Public Service Commission (Composition and Conditions of Service of Members and Staff) Regulations, 1957 in order to revise the pension of the Chairman and Members of the Kerala Public Service Commission in view of the judgment of the Hon'ble High Court Kerala in the said Writ Petition and Government issued G.O(P)No.09/2017/GAD dated 15.03.2017 to achieve the above object.

CHAPTER - II

COMPOSITION OF THE KERALA PUBLIC SERVICE COMMISSION

In accordance with the provisions contained under Regulation 3 of the Kerala Public Service Commission (Composition and Conditions of Service of Members and Staff) Regulations 1957, made by the Governor under Article 318 of the Constitution of India, as amended from time to time, the Commission shall consist of a Chairman and 20 Members.

CHAPTER – III FUNCTIONS OF THE COMMISSION

The functions of the Kerala Public Service Commission are as laid down in Article 320 of the Constitution of India with regard to the services of the State. They are:

- i) To conduct examinations for appointment to various services of the State,
- ii) To advise Government on
 - a) Matters relating to method of recruitment to the various services of the State,
 - b) The principles to be followed in making appointments to the services of the State and in making promotion and transfers from one service to another and on the suitability of candidates for such appointments, promotions and transfers,
 - c) All disciplinary matters affecting Government Servants,
 - d) Claims of reimbursement of legal expenses incurred by the Government servants in defending legal proceedings instituted against them for act done or purported to be done in the execution of their duty,
 - e) Claims for award of injury pension to Govt. servants and
 - f) Any other matter referred to them by the Government.

The Commission is also discharging the additional functions entrusted to them by the State Legislature under Article 321 of the constitution of India as regards the services and posts in Government owned Companies, Corporations, Boards and bodies constituted by law and of the Local Bodies in the State and certain Co-operative institutions. Later, additional functions in respect of Various Universities in Kerala have been brought under the purview of the Commission.

The matters on which the Commission need not be consulted have been specified in the Kerala Public Service Commission (Consultation) Regulations, 1957 made under the proviso to Article 320(3) of the Constitution of India.

CHAPTER - IV

STAFF AND ACCOMMODATION

STAFF OF THE KERALA PUBLIC SERVICE COMMISSION

The total members of staff of the Commission during the year under report were 1764. The eight staff members working in Vigilance Cell were on deputation from the Department of Police and One Librarian on deputation from the Common Pool of Librarians.** In exercise of the powers conferred on the Commission under Clause 12 – Sub Clause 2 of the

Kerala Public Service Commission (Composition and Conditions of Service of Members and Staff) Regulation 1957, 25 posts in various categories were created for a period of 6 months in two spells with effect from 01.04.2017 and a further period of 6 months with effect from 01.10.2017. The details of Staff of the Commission during the period under report are given in Appendix I.

*Due to the non-availability of Librarian Gr.I from common pool category after repeated requests to Government, the Commission vide Decision No.28 dated 26.11.2012 decided to appoint Librarian on contract basis and appointed Sri.Syamkrishnan.R, as Librarian with effect from the FN of 02.09.2013 vide Order No. Estt-II(2)-2129/2008/GW dated 02.09.2013 of the Secretary, KPSC.

In addition to the above strength 29 Assistants and 5 computer Assistants Grade II are appointed in the office of Kerala Public Service Commission on Supernumerary Posts.

Seven vacancies for the post of Duffedar filled through Employment Exchange in the absence of willingness from office attendants for by transfer appintment.(File No.Estt.III(3) 27076/GW dated 27.12.2017)

Under Regulation 12 (2) of the Kerala Public Service Commission (Composition and Conditions of Service of Members and Staff) Regulation 1957, the Commission have created 13 posts as per Order No. Estt-II(3)-32900/08/GW dated 23.03.2017 for a period of six months from 01.04.2017 and 12 posts for a period of six months with effect from 01.10.2017 as per order No. Estt-II(3)-32900/08/GW dated 19.09.2017

VIGILANCE AND SECURITY OFFICER

The Vigilance and Security Officer of KPSC, Sri.Rajesh.N, Superintendent of Police (Non-IPS) has appointed to duty on 22.06.2017 AN vide order No. GO (Rt) No.1608/2017Home Dated 20.06..2017.

LEGAL RETAINER

Sri. P.C. Sasidharan, Advocate, High Court of Kerala is continuing as the Legal Retainer to Kerala Public Service Commission since 01.03.2011, he is authorised to conduct cases

before the Hon. High Court and Adv.Sri C A Majeed, posted as Legal Retainer to Kerala Public Service Commission w.e.f 01.04.2014 to appear before Ernakulam Bench of the the Kerala Administrative Tribunal and Adv.Sri S. Remesan also posted as Legal Retainer to Kerala Public service Commission to appear before the Kerala Administrative Tribunal Thiruvananthapuram Bench on behalf of the Commission.(vide order No. A VII (4) 36832/11/GW dtd 30/03/2017

ACCOMMODATION

The Kerala Public Service Commission have District Offices in all Districts and three Regional Offices at Kollam, Ernakulam and Kozhikode. The Head Office and Thiruvananthapuram District office of the Commission are situated at Thulasi Hill, Pattom, Thiruvananthapuram. In all there are 18 offices including the Head Office. The District Offices of Palakkad, Malappuram, Kozhikode and Kannur are accommodated in the respective Civil Stations of the Government of Kerala. The Regional Office, Kozhikode is also situated in the Civil Station, Kozhikode. The District Offices in Alappuzha, Pathanamthitta, Thrissur, Wayanad and Kasargod are functioning in rented buildings. The District Office Kottayam is functioning in Commission's own building. The Regional Office and District Office Ernakulam are functioning in GCDA building at Ernakulam with effect from 21.01.2013. The District Office, Idukki is functioning in the Kerala State Housing Board Building at Kattappana. The District Office and Regional Office at Kollam are housed in Corporation Building. The official residence of the Chairman at Thiruvananthapuram is also a rented building.

GUEST HOUSE

Kerala Public Service Commission acquired a Guest House on rental basis located at Vrindavan Gardens, Pattom Thiruvananthapuram owned by Kerala State Housing Board, is established to provide boarding facilities to Guests and to Experts who are invited by the Commission to assist in interviews, Practical Tests and evaluation of answerscripts

CHAPTER - V

RESEARCH AND ANALYSIS WING, ONLINE EXAMINATION CENTRES, CALL CENTRE, COMPUTERISED ATTENDANCE MANAGEMENT SYSTEM, AA&VW, WEBSITE, PUBLIC RELATIONS UNIT, ENQUIRY, INFORMATION DISSEMINATION SECTIONS AND LIBRARY

RESEARCH AND ANALYSIS WING

The main function of Research & Analysis Wing is co-ordination, planning and monitoring of selection process with a view to improving the quality of work and minimising delay in the different stages of recruitment, by conducting comprehensive studies and imparting in-service training to the members of the staff. Purchase and maintenance of computers and other allied equipments are also done through the R&A wing.

Notifications received from various recruitment sections are consolidated and steps for publishing them in the Gazette are done in the section. Correspondence with other Public Service Commissions and Union Public Service Commission are done by Research & Analysis Wing. Agenda for the sitting of the Commission is also prepared in this wing.

Details regarding Legislature Assembly interpellation are collected and furnished to the Government from Research & Analysis Wing for submission before the Assembly. During the year under report **170** questions were received from the Government and reply were given in **170** cases. The compilation of the Annual Report of the Commission and furnishing of statistical data relating to different stages of selection are also being prepared in the Wing.

The PSC Manual is revised by incorporating the modified procedures in tune with the Commissions policy of utilizing IT enabled services to make the recruitment process faster, accurate and more transparent.

The Technical committee constituted for the supervision of computerization in the office of the commission has been convened two times on **27/07/2017** and **27/09/17** during the report **2017-2018**. An amount of Rs.**2,20,00,000/-** (Rupees Two Crores and twenty lakhs only) was allotted during the financial year **2017-2018** in the plan fund. An amount of Rs**2,19,34,623/-** (Rupees **Two crores ninety lakhs thirty four thousand six hundred and**

twenty three only) has been spent for the up-gradation and modernization by way of purchasing hardware, other computer peripherals, payment of AMC charges and various training programmes etc and an unutilised amount of Rs.65,377/- (Rupees Sixty five thousand three hundredand seventy seven only) has been refunded.

TRAINING PROGRAMMES

E-OFFICE SYSTEM IN KERALA PUBLIC SERVICE COMMISSION

E -Office is a National projecct under the National E- Governance Plan, Department of Information Technology of india. E- Office aims to improve efficiency and increase transparency by replacing the old manual process with an electronic file system. E-Office was rolled out in KPSC Head office from 12.03.2018. All district and regional offices of Kerala PSC moved into E- Office platform by July 2018. A total of 4248 e-files were created as on 06.08.2018 in all these offices together. Kerala PSC has been included in the 'Super User Category' in the E-Office Monthly Report issued by Kerala State IT Mission. With the implementation of E-Office, Kerala PSC is growing steadly towards an exclusive electronic file managing environment.

ONLINE EXAMINATION CENTRES

Kerala Public Service Commission had set up and functioned 4 (four) Online Examination Centres at Thiruvananthapuram, Pathanamthitta and Eranakulam Kozhikode. Total capacity to hold **875** candidates at a time and **1,750** candidates can be examined with single pattern of question.

CALL CENTRE

The Call Centre functions from 10.15 am to 5.15 pm without break on all working days. Nearly **2,25,000**(two lakes twenty five thousand) calls were received during the year under report in the call centre.

COMPUTERIZED ATTENDANCE MANAGEMENT

Attendance Management Section has been established under Research and Analysis Wing to monitor the computerized attendance management in the offices of the KPSC .

APPOINTMENT AUDIT AND VERIFICATION WING

Appointment audit and verification wing was started with effect from 1.9.2011 as per GO(P)41/2010 P&ARD dated 14/12/10. A total no.of **23,846** applications were received during the year and total no.of **22,846** cases have been verified (including **5479** pending applications of last year) during the year under report. And **6,479** applications are pending for verification as on 31/03/2018. The detials of service verification are furnished in **Appendix XL**.



PUBLIC RELATIONS UNIT FUNCTIONS

The Public Relations Unit functions as an effective link between the Kerala Public Service Commission and the Public. The sustained effort of the Unit is instrumental in the maintenance of better rapport and good relations between the Commission and various media organizations including Press, All India Radio, Doordarshan, other TV Channels, Local Networks and Websites.

PERFORMANCE

Information intended for the Public is regularly being supplied by means of press releases and public statements. The dates of Examination and Interviews of the Commission are given due publicity through News Papers, All India Radio, Doordarshan, PSC Bulletin, other TV Channels and through Website of KPSC and Face book.

All the media organizations have extended wholehearted co-operation and rendered worthy assistance in giving due publicity to these matters. The opinions, suggestions, criticisms and complaints made by the general public, and the views of press and public leaders are brought to the notice of the Commission in time by the Public Relations Unit. Whenever necessary, detailed public statements, clarifications, etc are also issued by the Commission through Public Relations Unit. The Public Relations Unit functions also as an information centre. During the year 2017-2018 total **142** press releases were issued.

ENQUIRY WING

The Enquiry wing in the Head Office of the Commission works continuously from 8 am to 6 pm in two sessions on all working days. It consists of an Enquiry Officer, six Assistants. The Enquiry wing is rendering remarkable service to clarify the doubts of hundreds of candidates approaching the Commission in person.

PUBLICATION OF PSC BULLETIN

The PSC Bulletin, the official publication of the Commission, restarted publication with the release of the issue dated 01.06.1997. Ever since the restart of the publication, the PSC Bulletin is being published regularly as a fortnightly (24 issues in one year) on the 1st and 15th of every month without break.

Information oriented articles on contemporary issues and current affairs beneficial to job seeking youth are added along with the regular columns such as Clarification of doubts, Advice for Appointment, Ranked Lists, Short Lists, Interview Programme, Examination Schedule, Previous Questions and Revised Answer Key of Various Tests conducted by the Commission. Articles relating to Science and Culture and model questions on general awareness, numerical aptitude, mental ability etc. are published. The details of the Gazette Notifications inviting applications for selection to various posts form the main feature of the PSC Bulletin.

24 issues of PSC Bulletin have been published during the period under report. 56 new agents have been appointed to ensure the proper distribution of bulletin. 224Akshya E

-Centres and Kerala State Book mark have been allotted with PSC Bulletin agency.

DETAILS OF DISCIPLINARY ACTIONS IN CONNECTION WITH RTI 2005

A departmental disciplinary action was recommended by State Information Commission in the judgement of Sri. Siju Kumar. B (AP No.2425(1)14/SIC). As there was a contradiction in the replies given to Sri.Siju Kumar B, Sri. Pratheesh Kumar. L and Jinesh Kumar.M. The queries were with regard to the opportunity granted for the submission of experience Certificate in connection with the selection to the post of Painter KSRTC. The disciplinary action is pending.

DETAILS OF DISCIPLINARY ACTION RECOMMENDED BY STATE INFORMATION COMMISSION, KERALA

In a second appeal filed by Sri. Arunkumar R V involving request for copies of OMR answer script in respect of test held on 13.11.2010 for the post of Typist in Govt. Secretariat (Category No.349/08), the SIC on 09.11.2016 ordered to supply record called for by the appellant at free of cost. Since it was informed from the concerned section that the OMR sheet of the appellant was not available, the SPIO informed SIC that order dated 09.11.2016 could not be implemented for want of original OMR scripts. But the Commission did not accept this argument and recommended to submit report before higher officials concerned for supply of OMR answer sheet. Accordingly a report in the matter has been furnished to Secretary PSC and the same forwarded to SS1 section for further action.









RESERVATION GROUPS ADVISED ON OC AND BC TURNS GRAPHICAL REPRESENTATION



RECRUITMENT - COMPANIES / CORPORATIONS / BOARDS / LOCAL AUTHORITIES/UNIVERSITIES

Under Article 321 of the Constitution of India, an Act made by the Legislature of the State may provide for the exercise of additional functions by the Commission in respect of the Service of the Companies, Corporations, Boards, Local Authorities and Universities by the Kerala Public Service Commission Additional Functions Acts enacted by the Legislature from time to time. Selection process to various posts to these institutions are carried on in Corporation Wing which functions under a Additional Secretary. At present there are **101** Companies, Corporations, Boards, Local Authorities and **13(thirteen)** Universities for which recruitment of candidates is made through Kerala Public Service Commission.

During the reporting year **55** posts were notified for selection to various posts in Companies, Corporations, Boards and Local Authorities for which **50,42,493** applications were received. **3,779** candidates were advised to these bodies.

CHAPTER - X

RECRUITMENT – CO-OPERATIVE SECTOR

The Kerala Public Service Commission (Additional Functions as Respects Certain Societies) Act has come into force as per Act 5/96 empowering the Commission to exercise additional functions in regard to the recruitment of employees in 15 Apex Co-operative Societies and District Co-operative Banks. The rules under the Act viz, The Kerala Public Service Commission (Consultation by Committee of Co-operative Society) Rules, 1998 were issued on 10.03.1998. Selection process to various posts to these bodies are carried out in Co-operative Sector Section, which functions under a Joint Secretary. Selection process for 14 District Co-operative Banks, 15 Apex Co-operative Societies and 3 other societies are left under the purview of the Commission. At present there are 32 Co operative institutions are under the preview of the Commission.

During the reporting year **43** posts were notified for selection to various posts in Cooperative sector for which **1,11,045** applications were received and also **568** candidates were advised by the commission.

CHAPTER – XI

SPECIAL RECRUITMENT FOR SCHEDULED CASTES AND SCHEDULED TRIBES

In accordance with the policy of the Government and as provided for in Rule 17 A of the Kerala State and Subordinate Service Rules, 1958 the Commission continued the Special Recruitment of Scheduled Caste/Scheduled Tribe candidates in respect of vacancies reported by the appointing authorities.



GRAPHICAL REPRESENTATION















CHAPTER - XXV

DEVIATION FROM THE ADVICE OF THE KERALA PUBLIC SERVICE COMMISSION

1 **A1(1)444/2014/GW**

The disciplinary action initiated against Sri.'A' Deputy Conservator of Forests (Rtd) in connection with the irregularities in the unwarranted construction of 500 jundas in the vested forest area in Manchucholamala in Kottenchery in Kanhangad range during 1997-1998 was finalized by Government by awarding him the punishment of reduction in pension for Rs.200/- per month permanently and to recover Rs.9,14,964/- from him under Rule.3 Part III, KSR, after obtaining advice of the Commission in this regard.

The review petition dated 25/05/2011 filed by Sri.'A' against the above order

was rejected vide Government order dated 18/02/2012. He again filed another review petition which was also rejected vide Government letter dated 05/06/2012. Once again Sri.'A' submitted his review dated 19/06/2012 and the same was rejected vide Government letter dated 14/11/2012 informing that no further request in this regard will be entertained.

Sri.'A' has submitted one more review petition dated 27/11/2012 with the main contention that jurisdiction conferred under Rule 39 of Part II of KS&SSR 1958 may be invoked for canceling the implementation of Government Order.

Having decided to invoke Rule 39 of KS&SSR, 1958 Government once again examined the case in detail and observed that on going through the materials available in the file, it cannot be inferred that the actions of the petitioner were ill motivated or that there was any sinister design on his part. On the other hand, it appears that there was bonafides on his part in view of the pendency of court proceedings. Moreover, no reliable material is forthcoming to suggest that he had any personal gain due to the alleged unwarranted construction of jundas in the vested forest area. With the above observations, Government vide letter dated 04/12/2013 first has requested the advice of the Commission in this matter.

The Commission examined the case in detail and observed as follows;

Rule 35 of KCS(CC&A) Rules specifically states that there shall be only one review. Here the delinquent had preferred three reviews which were considered and rejected by the Government and this is the fourth such petition filed by the delinquent and the Government invoked Rule 39 of KS&SSR to re-examine the case. The Hon'ble High Court had observed in Narayanan Vs State of Kerala that the power under Rule 39 is to be exercised in rare and

exceptional case in extra ordinary circumstances where ends of justice demand it. Clearly there are no such compelling reasons in this case.

Moreover, records reveal that the enquiry had found the delinquent guilty of all the four charges. The main contention of the delinquent is that there was a interim order by the Hon'ble High Court and he constructed jundas to prevent further encroachment and cultivation by the appellants. But the order of the High Court states that "there shall be no further plantation in the area covered by the order nor shall the appellants cut or remove any tree or convert the present state of the property until further orders". So it is evident that the appellants were forbidden by the Hon'ble High court from creating any further mischief. So there was no urgency to demarcate the forest land from the disputed land before the disposal of the appeal by the court.

The High Court finally dismissed the appeals preferred by the party and decided in favour of the department. So the creation of jundas before the final disposal of the appeal has caused infructuous expenditure to the Government and that delinquent has been proved to be responsible for the loss caused to the Government. There are no fresh reasons to deviate from the earlier three decisions of the Government wherein the review petitions were dismissed as they lacked merit.

As per Rule 4(ff) of KPSC (Consultation) Regulations it shall not be necessary for the Commission to be consulted in regard to the making of any order in exercise of the power conferred by Rule 39 Part II of KS&SSR. This has been upheld in KPSC V/s Tessymol Sebastain and another LLR 2005 (3) Ker 486. But even a plain reading of the section would reveal that Rule 39 does not empower the Government to entertain a fourth review petition from a retired employee. Rule 39 Part II of KS&SSR relates to "the case of any person or

persons serving in a civil capacity under the Government of Kerala or any candidate for appointment to a service". It does not extend to disciplinary action against retired employees. So the present decision to invoke Rule 39 is clearly ultravires.

Therefore, with the above observations, the Commission disagreed to the Government proposal and advised the Government accordingly, vide letter dated 01/01/2014.

Government examined the case again on the basis of the remarks furnished by the Advocate General in this case. The questions of the power of review of the Government under Rule 35 of KCS(CC&A) Rules and the entertainment of an issue by resorting to Rule 39 of Part II of the KS&SSR are seen addressed by the Advocate General, as requested by the Government. Regarding the entertainment of the issue by resorting to Rule 39 of Part II of the KS&SSR, the Advocate General has opined that the relief sought by the incumbent in this case cannot be indirectly achieved by invoking the general and residuary power of the Government under Rule 39 of the Rules. Regarding the power of review of the Government under Rule 35 of KCS(CC&A) Rule, Advocate General has opined among other things that there can be only one review to the Government against the original decision taken by the Government and though technically a second review is not maintainable, the Government is not debarred from having a second look on the whole issue on the basis of subsequent revelation of material facts which were unnoticed and overlooked in the earlier adjudications.

Based on the remarks of Advocate General and taking a lenient view Government have decided to reduce the punishment of deduction of ₹.200/- from pension ordered vide GO(Rt)No.234/11/F&WLD dated 02/06/11 to ₹.100 after keeping alive the decision to recover the Government loss of ₹.9,14,964/- from the DCRG of Sri.'A' as ordered therein.

The Commission examined the case with connected records and found that no new

material facts or any change of circumstances have been revealed subsequently in this case and hence the tentative decision taken by the Government afresh is not proper in the eye of law. The Commission therefore decided to stick on to its earlier decision and advise the Government accordingly on 24/02/2016.

But the Government vide G.O.(Rt)No.302/2017/F&WLD dated 06/08/2017 has decided to finalise review petition submitted by him by reducing the punishment of deduction of pension ordered vide G.O.(Rt) No.234/11/F&WLD dated dated 02/06/2011 from ₹.200 to ₹.100 keeping alive the decision to recover the loss of ₹,9,14,964 from the DCRG of Sri.'A' overruling the advice tendered by the Public Service Commission and without affording them another opportunity to examine the case.

2. AI (3) 1552/17/GW

Government have earlier sought the advice of the Commission on their tentative decision to withhold ₹.700 per month from the monthly pension of Sri. 'X', Chief Engineer (Rtd) for a period of 5 years under Rule (3) Part III KSRs, as he violated the norms in awarding contract to erect Sign Boards along National Highways. The Commission examined the case in detail with connected records and disagreed to the tentative decision of the Government to withhold ₹.700 per month from the monthly pension of Sri. 'X' and advised the Government to stick to its earlier decision to reduce ₹.1000/- per month permanently from his monthly pension Overruling the advice of the Commission. Government vide G.O(Rt)No.735/2016/PWD dated 01/04/2016 finalised the disciplinary action initiated against Sri. 'X', Chief Engineer (Rtd) by withholding ₹.700 per month for a period of 5

years as per Rule 3 Part III KSRs. It is by deviating from the provisions laid down to be followed in case of disagreement between the Commission and the Government, vide the above G.O. Government finalised the disciplinary action without giving a chance to the Commission to reconsider the matter. In this regard, Commission brought the procedural impropriety to the notice of the Government and further noted its concern on the repeated deviations from the accepted norms. Now, vide letter dated 2/8/17, Government have informed that the concern raised by the Kerala Public Service Commission in the matter of procedural impropriety occurred in the matter of finalizing the disciplinary action against Sri. 'X', Chief Engineer (Rtd) is duly acknowledged and that there was no deliberate intention to deviate from the norms and also noted that such instances shall be avoided in future.

3.A(1)8082/15/GW

While working in KAP 3rd Battalion Sri 'A' went into unauthorised absence from 27.01.2009 with out prior notice or permission from the Authority.He was declared as absconding from duty and departmental enquiry was initiated against him for his indiscipline and failure from duty which were not expected from a personel in a disciplined force.The commandant of KAP,3rd Battalian on 23.01.2010 odered to remove Sri 'A' from his service w.e.f.27.01.2009 (the date from which he became absent)conforming to the report of enquiry officer which undoubtedly proved accusations against him.But Sri 'A' did not submit any appeal against the punishment on department level.Later it was on 25.02.2015 the mother of the incumbant appealed Govt.to neutralize the order dismissing Sri 'A' from service.The Govt.heard Sri 'A' to finalise the appeal made by his mother.

On hearing Sri.'A' claimed that due to severe stomach pain he was forced to leave from his duty place on 27.01.2009.He had to abstain from his duty because of the severing of

his discomfort and physical fatigue and hence he was not able to respond to the showcause notice issued to him. He never got a chance to prove his innocence and he was dismissed from service without hearing his plea.

He appealed to Govt. that the order intended to dismiss him from service may be withdrawn since he had not committed any crime testifying to remove from service.

Govt. closely examined the review petition filed by Sri A vide Rule 36 of Kerala Police Departmental Enquiries Punishment & Appeal Rules,1958. , P.R file concerned, associated documents and claims made by the incumbant while hearing were brought for examination. Govt observed that he was removed service since his unauthorised abstinence from duty was clearly proven in the enquiry. Even the accused did not cooperate with the departmental procedures. Neither did he give reply to the showcause notice nor did he take any action to clear his stand in the departmental enquiry. Neverthless on considering the symphethetical condition of his family and the fact that he is of only 41 years of age. Government for the time being decided to reinstate him into the service thereby reducing the punishment of termination from service to increment bar with 3 years cumulative effect.

Accordingly, the advice of the Hon'ble Commission was soughtby the Govt. On detailed inspection, the Commission disagreed with tentative decision of Govt. as righteous reasons were not found and advised the Government accordingly.

After obtaining the advise of the Commission ,Government re-examined the case. Even though gross failure had been occured on the part of Sri A, Govt. stuck on the earlier decision to lowering the punishment of dismissal from service to increment barring with 3 years cumulative effect showing compassinate approach by considering the

sympathetic conditions of his family and also considering the fact that he will get nearly 15 years of service if he is re- appionted in service and therefore appealed to the Commission to re consider the decision vide letter dated 10.11.2016.

The Commission scrutinised then documents thoroughly and disagreed with the proposal of Govt.with a view that there was no genuene reason put forward by the Govt.inorder to reduce the punishment.

Overruling the advice tendered by the Commission ,Govt.vide G.O (P) 3339/2017/Home dated 14/12/2017 has decided to lower his punishment by increment bar with 3 years cumulative effect and to reinstate Sri 'A' into service.

4. Kerala State Development Corporation for Christian converts from Scheduled Caste-Regularisation of appointment of Sri. Dineshan.G as LD Typist.

Government have sought the advice of the Commission to regularise the appointment of Sri.Dinesan as Driver in KSDC for CC from SC. But the commission has disagreed with the Government proposal and once again Government requested to reexamine the matter and the commission stick on to the earlier decision. Later Government issued an Order Vide GO(MS) No. 11/2017/BCDD dt. 11.07.17 to regularise the appointment of Sri. Dinesan.G by overruling the advice of the Commission.

5. Absorption of Seven Office Attendants from Government Secretariat to Kerala University of Health Services

Government have sought advice of the Commission to absorb 7 Office Attendants, deputed from Government Secretariat to KUHS. The commission disagree with the Government proposal twice and Government over ruled the Commission advice and issued the order to absorb the office attendants from Government Secretariat to KUHS as per GO(MS) No. 164/2017/H&FWD dt. 18.11.17

CHAPTER – XXVI COMPARATIVE SUMMARY OF WORK DONE BY KERALA PUBLIC SERVICE COMMISSION

At the initial stage the workload of the Commission was limited. As years passed a remarkable change has occurred in the growth of literacy, as a result number of well-educated youth has also increased in the State. Accordingly the number of job seekers has become enormous. Applications received for various posts began to be heaped up in all the offices of the Commission. Requests for increasing the strength of Staff had been placed to the government on several occasions and the Government have accepted the same to a certain extent. Thus, the total strength of the staff reached up to 1,764 during the reporting year 2017-2018 Since the manpower was found insufficient to cope with the enormously increasing workload the Commission resorted to mechanization with effect from 2002, so as to achieve simplification, accuracy and speed in the selection process. A tabular form of comparative study of work done for the last ten reporting years (2008-2009 to 2017-2018 and five years comparison of work done (2008-2009 to 2012-2013 & 2013-2014 to 2017-2018) are shown in the succeeding pages.




