Note :- (5) Candidate belonging to SC/ST Candidates included in the Short List are required to produce Community Certificate in Form III/ Digitally signed and candidates belonging to other Reservation groups are required to produce Non Creamy Layer certificate as per G.O (P) No.81/2009/SC/STDD dated 26.09.2009 or EWS certificate vide GO (M S) No2/2020/P&ARD dated 12-02-2020, issued by the Revenue authority at the time of OTR Verification.

Note :- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (7) Copy of answer scripts of the OMR Test held on 03-09-2024 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answer script is invalidated as per Notification No :ER2-1/17/2024-KPSC Dated.10-12-2024
