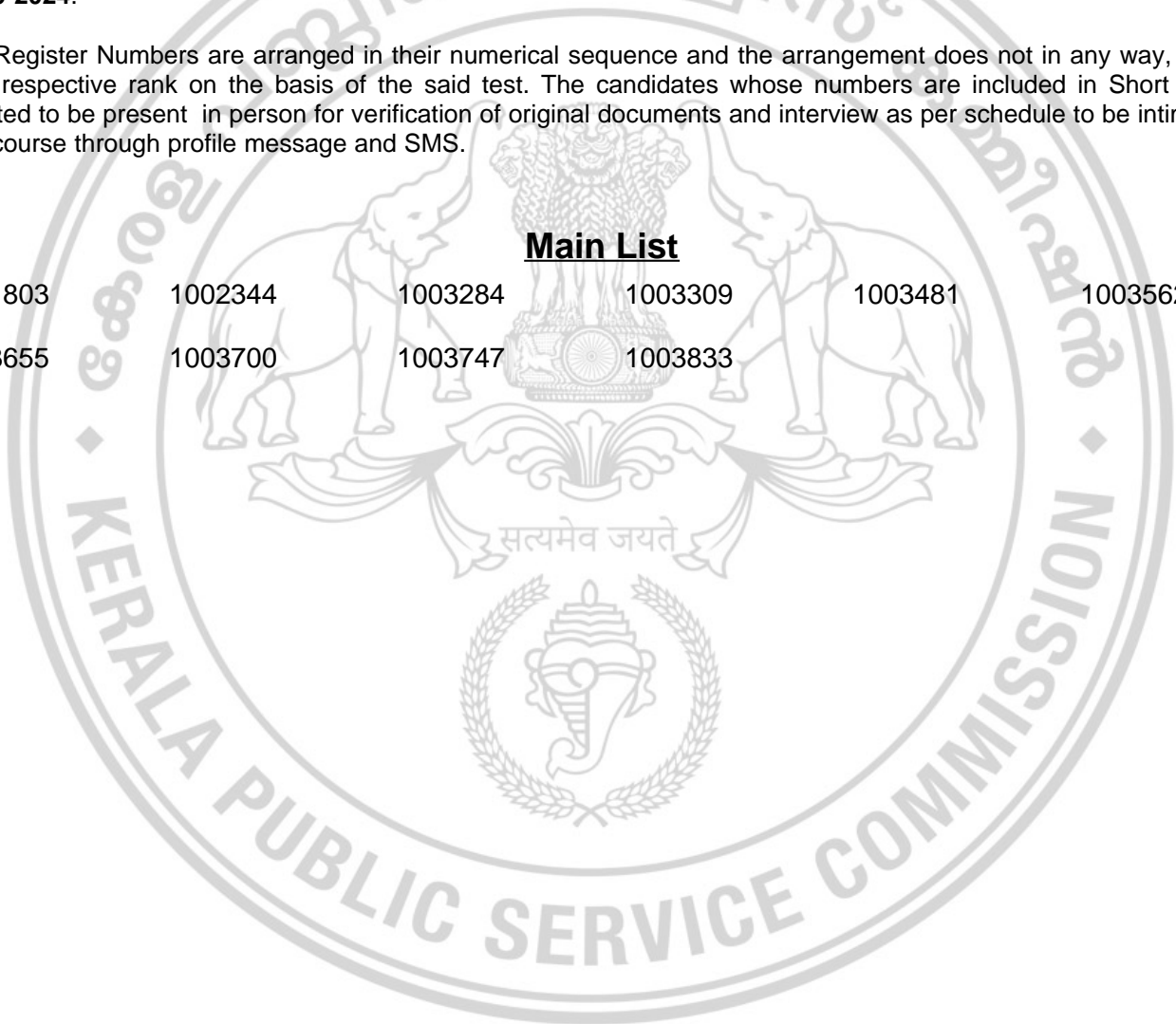
NOTIFICATION

Note :- (5) The Register Number of those candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the Short List without further notice.

Note :- (6) Candidates included in the Short List are required to produce Non Creamy Layer Certificate as per G.O(P)No.81/09/SC/ST/DD dated 26.09.2009 issued by village officer at the time of OTR verification.

Note :- (7) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (8) Copy of answer scripts of the OMR Test held on **09-09-2024** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No candidate is invalidated for the above mentioned post vide Invalidation Notification no. ER6-2/8/2024-KPSC dated 11/12/2024.
