NOTE (1) :- The Ranked List will be in force till the publication of a new Ranked List after the expiry of a minimum period of one year or till the expiry of three years whichever is earlier. A period of 15 (fifteen) days time to apply for image and tabulation sheet of answer sheets will be allowed to candidates with effect from the date on which the RankedList is uploaded in the website of the Commission.(ie, on or before 28.02.2025). Application submitted in any other manner (ie, via Email/Tappal/Direct) will not be considered. A copy of the answer sheet will be issued only once to acandidate. Copies of answer sheets invalidated due to any defect will not be issued.

NOTE (3) :- The entries put in column (10) are based on the Communities specified by the candidates in their application forms and proved by them with necessary documents. The candidates whose Communities have not been correctly noted in the Ranked List as proved by them in their application should intimate the fact to **The Deputy Secretary(Examinations)** -I, Kerala Public Service Commission, Thiruvananthapuram - 695004 within one month from the date of publication of the Ranked List to get the benefit of Reservation to which they are entitled to. In the absence of timely information regarding discrepancies if any, the candidate will be advised as incorporated in theRanked List.

The request for relinquishment along with the original of notarized affidavit and self attested copy of the ID Proof received within 15 days from the date of publication of Ranked List in the Official Website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalisation of the Ranked List. After the publication of Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of vacancy, based on which he/she is to be advised.
