Note :- (2) The Short list has been prepared by including eligible and qualified candidates who have secured top marks in the OMR Exam held on 03.10.2024, based on the details furnished by the candidates in the application for the post. Subsequent claims made will not be entertained at any stage.

Note :- (3) **50 (Fifty)** candidates who have secured top most marks in the OMR Test are included in the Main List of this Short list. The marks secured by the last candidate in the Main List is **70.33 (Seventy (point) three three)**. For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes, Economically Weaker Section and Differently Abled, necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note:- (4) Candidates included in the Short List should present and produce in person the original documents for One Time Verification and Interview. **Date,time and Venue of OTR Verification will be published in due course..**

Note :- (5) According to the existing procedure, revaluation and rechecking of answer scripts are not allowed. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates included in the Short List who are eligible for reservation are required to produce Non Creamy Layer Certificate as per GO(P)No.81/09/SC/STDD dated. 26.09.2009 , SC/ST Candidates are required to produce Community Certificate issued under Rule 4 of Kerala (SC/ST) Regulations of issue of Community Certificate Rules 2002 by the Revenue authority not below the Rank of Tahsildar and candidates claiming reservation under EWS category are required to produce EWS Certificate issued by Village Officer as per GO(Ms) No.2/2020/P&ARD dated 12.02.2020 along with other documents at the time of OTR Verification.

Note:- (7) The Register number of those candidates who do not produce the required documents within the prescribed time limit and whose applications found otherwise defective will be deleted from the Short List without further notice.

Note :- (8) Copy of answer scripts of the OMR Test held on **03-10-2024** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer Notification No : **ER 3-3/5/2024-KPSC dated 27.12.2024.**
