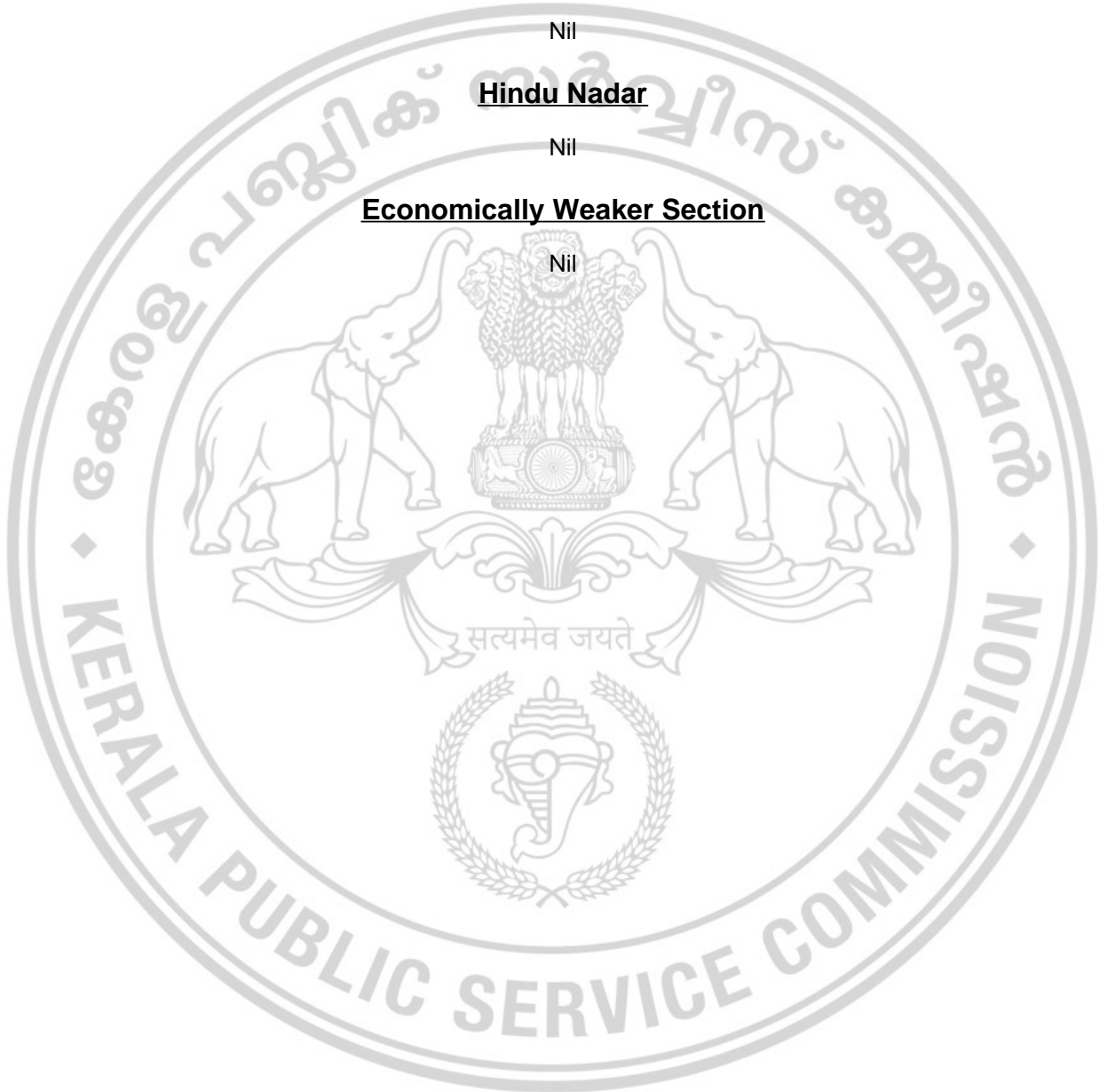

(MS) No :02/2020/P&ARD dated 12/02/2020 issued by Village Officer as proof of their claim, along with other relevant documents at the time of OTR Verification.
