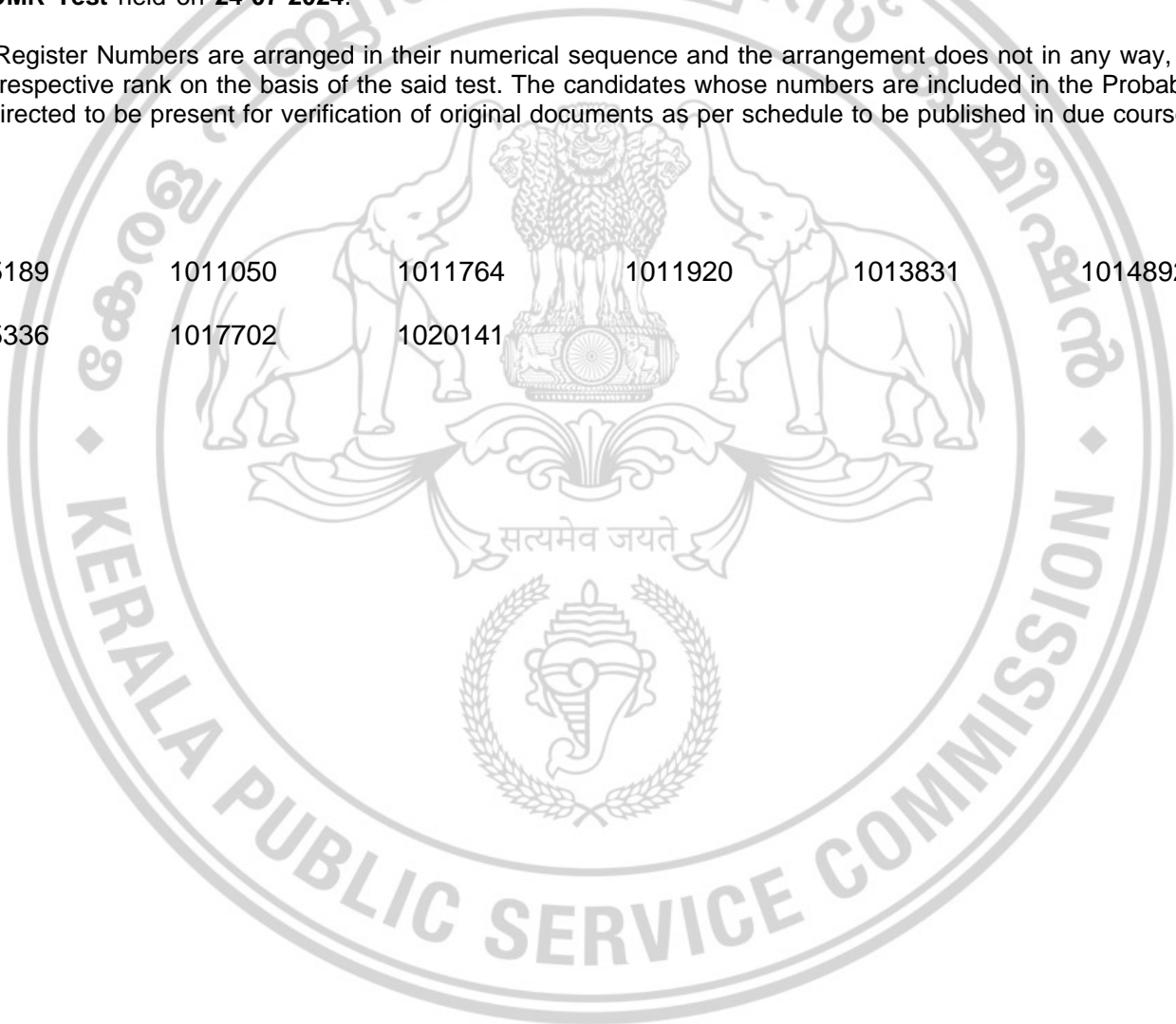

Note :- (6) Candidates belonging to the Other Backward Classes included in the probability List are required to produce a Non Creany Layer Certificate as per G.O. (P) no.81/2009/SCSTDD dated : 26.09.2009, SC/ST candidates are required to produce a Community Certificate either in Form III or digitally signed certificate issued by Revenue Authority not below the rank of a Tahasildar and an EWS Certificate issued by the village officer as per GO(MS) No.23/2022/P&ARD dated : 18/10/2022 in case of candidates having EWS reservation at the time of OTR.

Note :- (7) Copy of answer scripts of the OMR Test held on **24-07-2024** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
