Note:- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates belong to Other Backward Classes included in the Probability List , eligible for reservation are required to produce Non Creamy Layer Certificate as per G.O (P) No.81/09/SC/STDD dated 26.09.2009 issued by Village Officer and SC/ST candidates are required to produce Community Certificate (Form III/ Digitally signed) issued by the Revenue Authority not below the rank of Tahsildar and candidates who claim EWS reservation are required to produce EWS Certificate as per GO(Ms) No.23/2022/P&EA dated 04.10.2022 issued by the Revenue Authority along with other documents at the time of OTR verification of original documents.

Note :- (7) Copy of answer scripts of the OMR Test held on **13-08-2024** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No :ER7-2/9/2024-KPSC Dated: 05/11/2024.
