NOTE (3):- Since a Common Dictation cum Transcription Test with common candidates was conducted to this post, the marks awarded to the candidates included in this Ranked List and mark of all candidates appeared for the Test will be published only after the publication of entire Ranked List (including NCA Notifications if any) which will be finalized on the basis of the common Dictation cum Transcription Test held on **27.01.2023**.

NOTE (4):- The candidates who wish to relinquish their claim for advice from the Ranked List shall submit an application in the format prescribed by the Commission to **The Secretary, Kerala Public Service Commission, Head Office, Pattom, Thiruvananthapuram-4**. The format is available in the official website of the Commission. The request for relinquishment in respect of those who do not submit the relinquishment application in the format prescribed by the Commission will not be honoured under any circumstances. The request for relinquishment in the prescribed format should be duly attested by a Gazetted Officer of State/ Central Government with signature, name, designation and office seal along with a notarized affidavit and a self attested copy of an ID proof bearing photograph as enlisted in the General Conditions. The request for relinquishment, along with the original of notarized affidavit and self attested copy of an ID proof received within 15 days from the date of publication of Ranked List in the official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalisation of the Ranked List. After the publication of the Ranked List the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition based on which he/she is to be advised.
