(P) no.81/2009/SCSTDD dated:26.09.2009, SC/ST candidates are required to produce a Community Certificate either in Form III or digitally signed certificate issued by Revenue Authority not below the rank of a Tahasildar and an EWS Certificate issued by the village officer as per GO(MS) No.23/2022/P&ARD dated:18/10/2022 in the case of candidates having EWS reservation,at the time of OTR.
