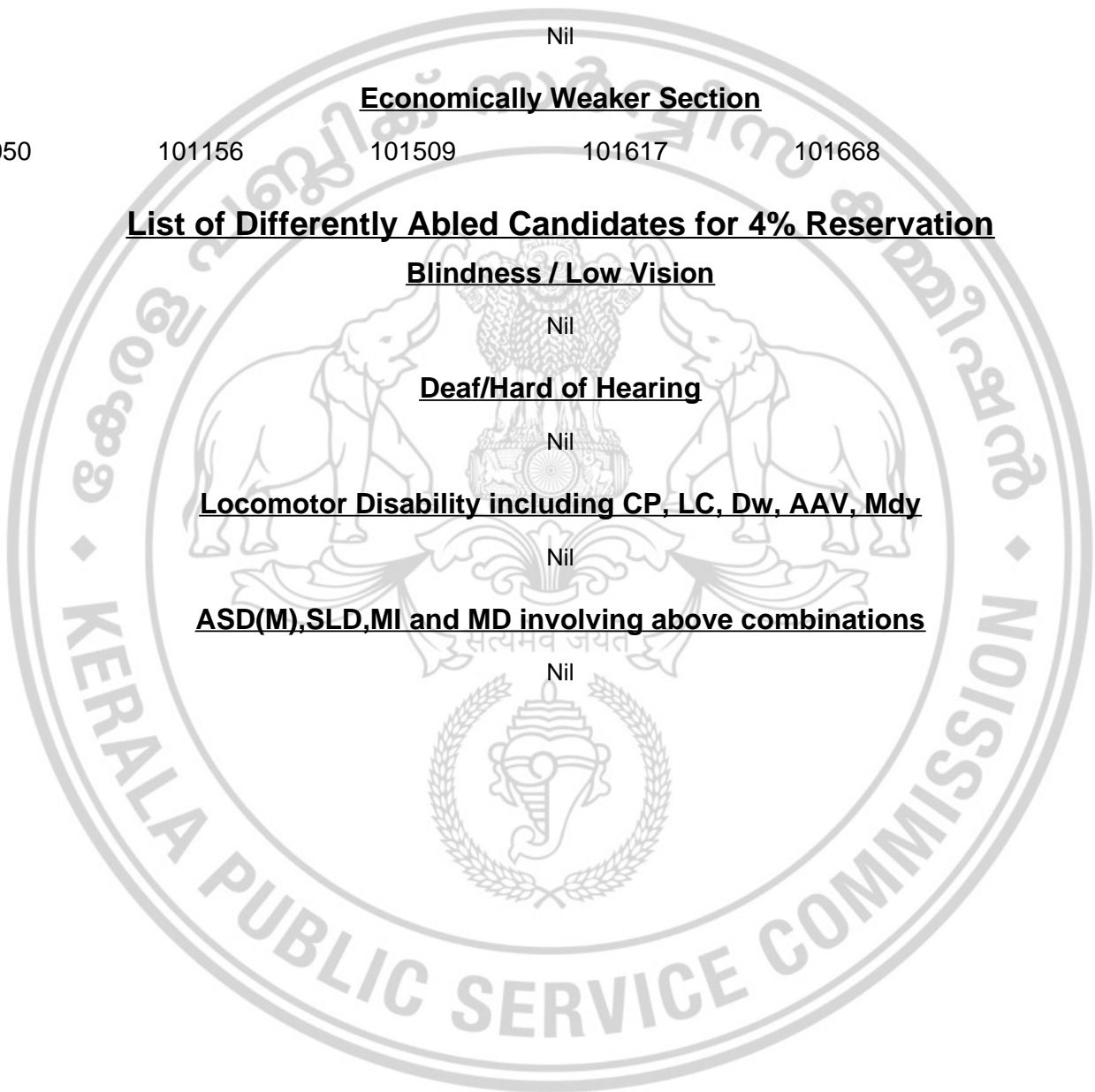

For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled tribes Other Backward Classes and Economically Weaker Section category ,necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) Candidates included in the Short List should present and produce in person the original documents for One Time Verification and Interview. . **Date,time and Venue of OTR Verification and Interview will be published shortly.**

Note :- (5) For Online Examination , rechecking and revaluation are not allowed but printout of answer sheets will be issued to those candidates who apply for it by remitting the prescribed fee after the publication of Ranked List. Detailed instructions will be furnished in the Ranked List to be published for the post.

Note :- (6)The Register number of those candidates who do not produce the required documents within the prescribed time and those applications found otherwise defective will be deleted from the Short List without further notice.

Note :- (7) The short list is prepared based on the details furnished by the candidate in the application and subsequent claims made will not be entertained at any stage.

Note :- (8) Candidates belonging to Other Backward Classes included in this list are required to produce Non Creamy Layer Certificate as per G.O.(P) NO. 81/2009/SC/STDD dated 26.09.2009, candidates belonging to SC/ST are required to produce Community Certificate in Form III /Digitally signed issued by the Revenue authority not below the rank of Tahsildar and candidates belonging to Economically Weaker Section are required to produce EWS Certificate vide G.O. (M.S) No. 2/2020/P&ARD dated 12.02.2020 issued by the concerned authority at the time of OTR Verification.
