For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Shceduled Tribes, OtherBackward Classes ( and other reserved Categories if any ) necessary supplementary lists prepared by including sufficient number of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes

Note :- (3)Candidates included in the Probability List should present in person and produce the original documents for One Time Verification. Date,Time and Venue of OTR Verification will be intimated in due course

Note:- (4) The Probability List is prepared based on the details furnished by the candidates in the application and subsequent claims made will not be entertained at any stage

Note:- (5) According to the existing procedure, reevaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates included in the Probability List who belong to Other Backward Classes are required to produce Non- Creamy Layer Certificate issued by Village Officer ,SC/ST Candidates are required to produce Community Certificate by the Competent authority not below the Rank of Thasildar and candidates claiming reservation under EWS category are required to produce EWS Certificate issued by Village Officer along with other documents at the time of OTR Verification.

Note :- (7) The Register number of those candidates who do not produce the required documents within the prescribed time limit and whose applications found otherwise defective will be deleted from the Probability List without further notice.

Note :- (8) Copy of answer scripts of the OMR Test held on 30.09.2024 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No : ER1-3/6/2024-KPSC dated 01.02.2025.
