

Note :- (6) SC/ST Candidates included in the Probability List are required to produce Community Certificate either in Form-III or Digitally Signed issued by the Revenue authority not below the rank of Tahasildar, candidates belonging to Other Reservation Group are required to produce Non-Creamy Layer Certificate issued by the Village Officer as per GO(P) No.81/2009/SC ST DD dated 26/09/2009 and those belonging to Economically Weaker Section category are required to produce EWS Certificate in the format prescribed vide GO(Ms) No.02/2020/P&ARD dated 12/02/2020 in proof of their claim along with other relevent documents at the time of One Time Registration Verfication of original documents.
