The following is the list of candidates for selection to the post of **SALES ASSISTANT GRADE II(SOCIETY CATEGORY)(SECOND NCA -EZHAVA/BILLAVA/THIYYA)(CATEGORY NUMBER : 111/2023)** on Rs 15190-30190 in **KERALA STATE CO-OPERATIVE COIR MARKETING FEDERATION LIMITED**, found suitable by the Commission and arranged in the order of merit for recruitment against the NCA vacancy for Ezhava/Billava/Thiyya community on the basis of common OMR test held on 06/08/2024. This NCA Ranked List is brought into force with effect from 05/03/2025 and will be valid till the candidate is advised and appointed against the vacancy notified due to the paucity of candidates belonging to Ezhava/Billava/Thiyya community during the currency of Mother Ranked list published on 09/04/2021 (Cat. No. 387/2018) for the post.

NOTE (1) :- According to the existing procedure, revaluation of Answer Script is not allowed. But Answer Scripts will be rechecked if the candidates apply through their One Time Registration profile from the Commission's official website www.keralapsc.gov.in by remitting the prescribed fee of Rs. 85 /-(Rupees Eighty Five only). The fee can be remitted by e-payment through the portal. Applications submitted in any other manner will not be considered. A period of 15 (Fifteen) days time to apply for rechecking of Answer Scripts will be allowed to candidates with effect from the date on which the Ranked List is uploaded in the website of the Commission (ie. on or before 19/03/2025). The candidates can avail only one chance after the Approval of Ranked List. Rechecking of invalidated answer scripts due to any defects will not be considered. Application for Rechecking received after the stipulated time will not be entertained and Fee once remitted will not be refunded

NOTE (2) :- Candidates who wish to obtain a photocopy of their OMR Answer Sheets (Part A & Part B) relating to this selection shall submit online application through their One Time Registration profile from the official website of the Commission-www.keralapsc.gov.in by remitting the prescribed fee of Rs. 335/- (Rupees Three Hundred and thirty five only) via e-payment mode available in the portal. A period of 15 (Fifteen) days time to apply for photocopy of OMR sheets will be allowed to candidates with effect from the date on which the Ranked List is uploaded in the website of the Commission (ie. on or before 19/03/2025). Applications submitted in any other manner will not be considered. A copy of the answer sheet will be issued only once to a candidate. Copies of OMR answer sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so. Printout of the answer sheet will be issued only after the publication of the Ranked list of all the posts finalised on the basis of the common test.

NOTE (3) :- The entries put in column (5) are based on the Communities specified by the candidate in their Application forms and proved by them with necessary documents. The candidates whose Communities have not been correctly noted in the Ranked List as proved by them in their Applications should intimate the fact to **The Deputy Secretary (Examinations) -II, Kerala Public Service Commission, Thiruvananthapuram - 695004** within one month from the Date of publication of the Ranked List to get the benefit of Reservation to which they are entitled to. In the absence of timely information regarding discrepancies if any, the candidate will be advised as incorporated in the Ranked List.

NOTE (4) :- The candidates who wish to relinquish their claim for advice from the Ranked List shall submit an application in the format prescribed by the Commission to **The Secretary, Kerala Public Service Commission, Pattom, Thiruvananthapuram-695004**. The format is available in the Official website of the Commission. The request for relinquishment in respect of those who do not submit the relinquishment application in the format prescribed by the Commission will not be honoured under any circumstances. The request for relinquishment in the prescribed format should be duly attested by a Gazetted Officer of State/ Central Government with Signature, Name, Designation and Office Seal along with a notarized affidavit and a self attested copy of an ID proof bearing photograph as enlisted in the general conditions. The request for relinquishment alongwith the original of notarized affidavit and self attested copy of the ID proof received within 15 days from the date of publication of Ranked List in the official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalization of the Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of vacancy, based on which he/she is to be advised.

NOTE (5) :- Since a common OMR Test with common candidates was conducted for this post, the mark awarded to the candidates included in this Ranked list and the mark of OMR test relating to all the candidates appeared for the test will be published only after the publication of entire Ranked Lists (including NCA Notifications) which will be finalised on the basis for the common test. The result of rechecking of OMR answer scripts will be intimated in due course. But photocopy of OMR answer script will be issued only after the publication of the Ranked Lists for all the posts finalized on the basis of the common test held on 06.08.2024.

NOTE(6):-The A part and B part of OMR scripts will be destroyed after completing 6 months period from the date of finalisation of the last Ranked list included in the common test held on 06.08.2024.
