NOTE (1): The Ranked List will be in force for a minimum period of one year, subject to the condition that the said Ranked List will continue to be in force till the publication of a new Ranked List after the expiry of the minimum period of one year or till the expiry of three years, whichever is earlier. Candidates from the Ranked List will be advised for appointment in accordance with the rules and orders regarding reservation and rotation as amended from time to time, if applicable, against vacancies reported to the Commission during the pendency of the Ranked List. As the advice for appointment depends on the occurrence of vacancies, there is no guarantee that all the candidates included in the Ranked List will secure appointment. The candidates remaining in the Ranked List at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the Ranked List.

**NOTE (2):** For Online Examination, rechecking and revaluation are not allowed. Candidates who wish to obtain a printout of their Answer Sheets relating to this selection shall submit an online application through their One Time Registration profile from the official website of the Commission, www.keralapsc.gov.in, by remitting the prescribed fee of Rs. 335 (Rupees three hundred and thirty-five) via e-payment mode available in the portal. A period of 15 (fifteen) days will be allowed for candidates to apply for the printout of their Answer Sheet with effect from the date on which the Ranked List is uploaded on the Commission's website (ie on or before **18.03.2025**). Applications submitted in any other manner (i.e., via email/Tappal/Direct) will not be considered. A copy of the Answer Sheet will be issued only once to a candidate. Printouts of the Answer Sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for the printout of Answer Sheets that are not their own, and legal proceedings will be initiated against those who do so. Printouts of the Answer Sheets will be issued only after the publication of the Ranked Lists for all posts finalized on the basis of the Common Test.

**NOTE (3):** The entries in column (9) are based on the Communities specified by the candidates in their application forms and proved by them with necessary documents. Candidates whose Communities have not been correctly noted in the Ranked List as proved by them in their application should intimate the fact to the **District Officer, Kerala Public Service Commission, District Office Thiruvananthapuram-695004**, within one month from the date of publication of the Ranked List to get the benefit of Reservation to which they are entitled. In the absence of timely information regarding discrepancies, if any, the candidate will be advised as incorporated in the Ranked List.

NOTE (4): Candidates who wish to relinquish their claim for advice from the Ranked List shall submit an application in the format prescribed by the Commission addressed to the District Officer, Kerala Public Service Commission, District Office Thiruvananthapuram-695004, either directly or by post. The format is available on the official website of the Commission. Those who do not submit the relinquishment application in the prescribed format will not be honoured under any circumstances. The request for relinquishment should be duly attested by a Gazetted Officer of the State/Central Government with Signature, Name, Designation, and Office Seal along with a notarized affidavit and a self-attested copy of an ID proof bearing a photograph as enlisted in the General Conditions. The request for relinquishment, along with the original Notarized affidavit and self-attested copy of an ID proof, received within 15 days from the date of uploading of the Ranked List (ie on or before 18.03.2025) on the official website of the Commission will be honoured against the requisitions of vacancies pending with the commission up to the finalization of the Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which the candidate is to be advised.
