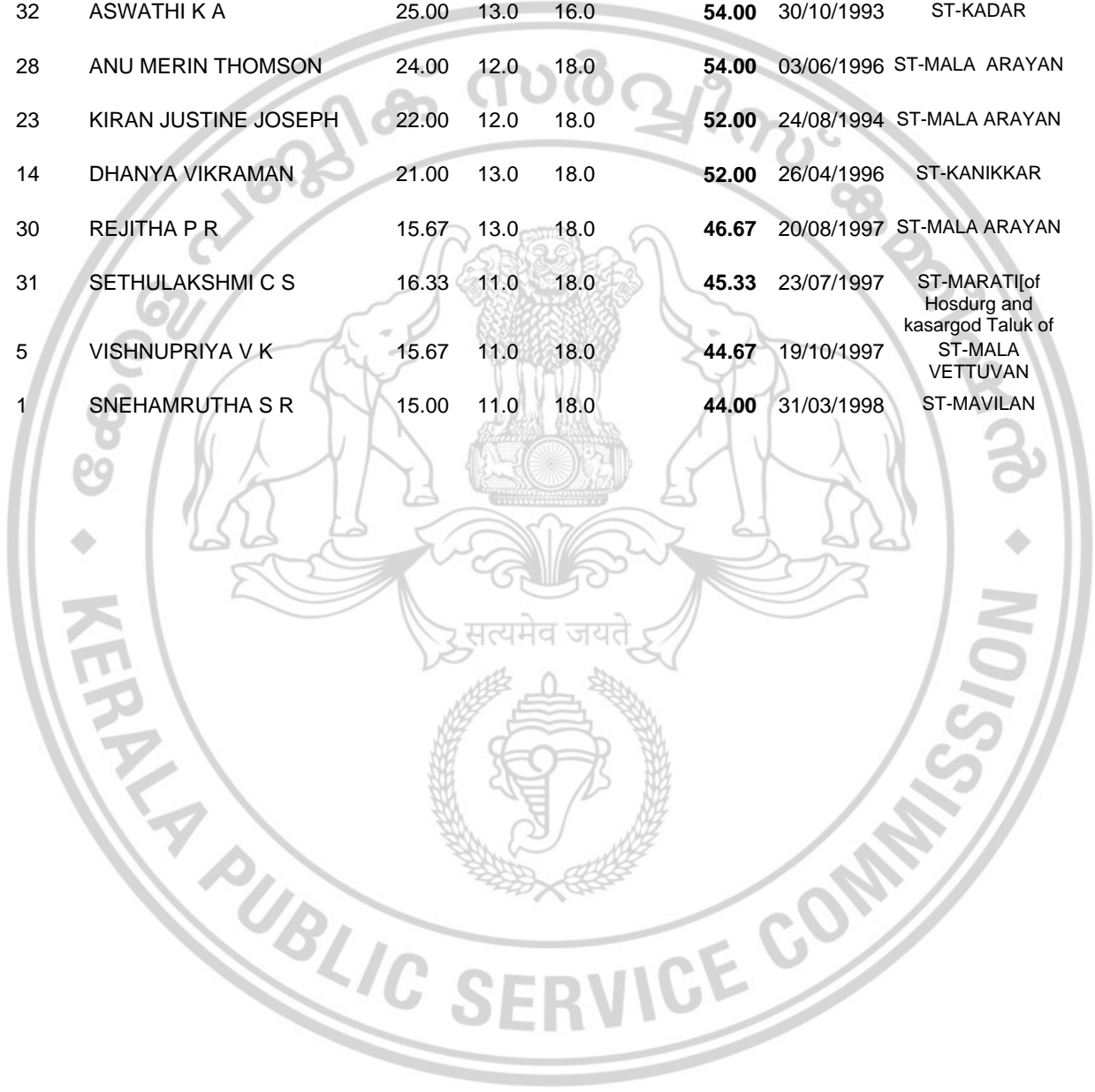

**NOTE (1) :-** The Ranked List of selected candidates shall remain in force for a minimum period of one year and a maximum period of three years provided that the Ranked List will not continue to be in force if a new list after the expiry of the minimum period of one year is published for this post under the same method of appointment. Advices for appointment will be made for the notified vacancies and also for the vacancies reported for Special Recruitment from Scheduled Caste/Scheduled Tribe during the pendency of the list. Vacancies of the above post reported exclusively for Scheduled Tribes will also be advised from this list and only in the absence of Scheduled Tribe candidates in this list, fresh notification for 'Scheduled Tribes' will be issued for such vacancies.

**NOTE (2) :-** Since a common OMR Test with common candidates was conducted for this post, the marks awarded to candidates included in this Ranked List and mark of OMR test relating to all candidates appeared for the test will be published only after the publication of entire Ranked Lists (including NCA Notifications) which will be finalised on the basis of the common test.

**NOTE (3) :-** The result of rechecking of OMR answer scripts will be intimated in due course. But photocopy of the OMR answer scripts will be issued only after the publication of the Ranked Lists for all the posts finalised on the basis of the common test.

**NOTE (4):-** According to the existing procedure, revaluation of Answer script is not allowed. But Answer scripts will be rechecked if the candidates apply for it through their One Time Registration profile from the Commission's official website [www.kerala.psc.gov.in](http://www.kerala.psc.gov.in) by remitting the prescribed fee of Rs. 85/- (Rupees Eighty Five only). The fee can be remitted by e-payment through the portal. Applications submitted in any other manner (ie via e mail/Tappal/Direct) will not be considered. A period of 15 (Fifteen) days time to apply for rechecking of Answer scripts will be allowed to candidates with effect from the date on which the Ranked List is uploaded in the website of the Commission. ie on or before 23/04/2024

**NOTE (5):-** Candidates who wish to obtain a photocopy of their OMR Answer sheets (Part A & Part B) relating to this selection shall submit online application through their One Time Registration profile from the official website of the Commission, [www.keralapsc.gov.in](http://www.keralapsc.gov.in) by remitting the prescribed fee of Rs. 335/- (Rupees Three Hundred and ThirtyFive only) via e-payment mode available in the portal. A period of 15 (Fifteen) days time to apply for photocopy of OMR sheets will be allowed to candidates with effect from the date on which the Ranked List is uploaded in the website of the Commission. ie on or before 23/04/2024 Application submitted in any other manner (ie via e mail/Tappal/Direct) will not be considered. A copy of the answer sheet will be issued only once to a candidate. Copies of OMR sheets invalidated due to any defect will not be issued.

**NOTE (6) :-** The entries put in column ( 5 ) are based on the Communities specified by the candidate in their Application forms and proved by them with necessary documents. The candidates whose Communities have not been correctly noted in the Ranked List as proved by them in their Application should intimate the fact to the Deputy Secretary (Examinations), Kerala Public Service Commission, Thiruvananthapuram-695004 within one month from the Date of publication of the Ranked List to get the benefit of Reservation to which they are entitled to. In the absence of timely information regarding discrepancies if any, the candidate will be advised as incorporated in the Ranked List.

**NOTE (7) :-** The candidates who wish to relinquish their claim for advice from the Ranked List shall submit an application in the format prescribed by the Commission to the Secretary KPSC, Pattom, Thiruvananthapuram-695004. The format is available in the official website of the Commission. The request for relinquishment in respect of those who do not submit the relinquishment application in the format prescribed by the Commission will not be honoured under any circumstances. The request for relinquishment in the prescribed format should be duly attested by a Gazetted Officer of State/Central Government with Signature, Name, Designation and Office Seal along with notarized affidavit and a self attested copy of an ID proof bearing photograph as enlisted in the general conditions'. The request for relinquishment, along with the original of notarized affidavit and self attested copy of the ID proof, received within 15 days from the date of publication of Ranked List in the official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalisation of Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of vacancy, based on which he/she is to be advised

**NOTE (8):-** The A part and B part of OMR scripts will be destroyed after completing six months period from the date of finalisation of last Ranked List included in the common test.
