Note :- (6) Candidates belong to Other Backward Classes included in the Short List, eligible for reservation are required to produce Non Creamy Layer Certificate as per G.O (P)No.81/09/SCSTDD dated 26.09.2009 issued by Village Officer and SC/ST candidates are required to produce Community Certificate (Form III/Digitally signed) issued by the Revenue Authority not below the rank of Tahsildar and candidates who claim EWS reservation are required to produce EWS Certificate vide G.O.(MS)No.2/2020/P&ARD dated 12.02.2020 issued by Village Officer along with other documents at the time of OTR verification of original documents.

Note :- (7)The Register number of those candidates who do not produce the required documents within the prescribed time limit and whose applications found otherwise defective will be deleted from the Short List without further notice.
