

Note :- (5) Candidates included in the Short List and belonging to Other Backward Classes are required to produce Non-Creamy Layer Certificate issued by Village Officer as per GO(P) No.81/2009/SCSTDD Dated.26.09.2009, SC/ST Candidates are required to produce Community Certificate issued under Rule 4 of Kerala (SC/ST) Regulations of issue of Community Certificate Rules 2002 by the Revenue authority not below the Rank of Tahsildar and candidates claiming reservation under EWS category are required to produce Income and Asset certificate issued by Village Officer as per GO (Ms) No. 2/2020/P&ARD Dated. 12.02.2020 as proof of their claim, along with other relevant documents at the time of One Time Verification.

Note :- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Copy of answer scripts of the Common OMR Test held on 24-10-2024 will be issued to those candidates who, apply for the same remitting the prescribed fee only after publication of entire Ranked Lists which will be finalized on the basis of Common test. Detailed instructions will be incorporated in the Ranked List to be published for the post.
