Note :- (4) 12 (Twelve) candidates who have secured top most marks in the OMR Examination are included in the Main List of this Short List. The marks secured by the last candidate in the Main list is **64.33 ( sixty four (point) three three )** . For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes,Scheduled Tribes,Other Backward Classes and Economically Weaker Section, necessary supplementary lists are prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes

Note :- (5) Candidates included in the Short List should present and produce in person the original documents for One Time Verification. **Date,time and Venue of OTR Verification and interview of candidates included in the shortlist will be intimated in due course.**

Note :- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (7)Candidates included in the Short List are required to produce Non Creamy Layer Certificate as per GO(P)No.81/09/SC/STDD dated 26.09.2009 for Other Backward Communities other than SC,ST .SC/ST Candidates are required to produce Community Certificate issued by the Revenue authority not below the Rank of Tahsildar and candidates claiming reservation under EWS category are required to produce EWS Certificate issued by Village Officer as per GO(P) No.03/2024/P&ARD dated 25.04.2024 along with other documents at the time of OTR Verification.

Note :- (8) Copy of answer scripts of the OMR Test held on **16-10-2024** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers invalidated are advised to refer to Notification No : ER7-2/1/2025-KPSC Dated15.01.2025
