Note :- (4) The register number of those candidates who do not produce the required documents within the prescribed time limit and whose applications found otherwise defective will be deleted from the Short list without further notice.

Note:- (5) Candidates included in the Short List should present and produce in person the original documents for One Time Verification and interview. **Date,time and Venue of OTR Verification and interview will be published in due course and intimated through profile messages.**

Note :- (6) SC/ST Candidates included in the Short List are required to produce Community Certificate (Form III or Digitally Signed ) and candidates belong to other reservation goups are required to produce Non Creamy Layer Certificate as per G.O(P) No.81/2009/SC/STDD dated 26.09.2009 or EWS Certificate vide G.O.(MS)No.3/2024/P&ARD dated 25.04.2024, issued by the Revenue authority at the time of OTR Verification along with other documents.

Note:- (7) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (8) Copy of answer scripts of the OMR Test held on **23-08-2024** will be issued to those candidates who apply for the same remitting the prescribed fee after the approval of the Ranked List.No answerscripts are invalidated as per Notification No :**ER 7-1/16/2024-KPSC dated 10/12/2024**
