Note :- (6) SC/ST Candidates included in the Probability List are required to produce Community Certificate in Form III or Digitally Signed, Candidates belonging to other reservation groups are required to produce Non Creamy Layer Certificate as per G.O.(P) No.81/2009/SC/STDD dated 26.09.2009 and those belonging to EWS are required to produce EWS Certificate vide G.O(MS) No.2/2020 P&ARD dated 12.02.2020 issued by the Revenue authority at the time of OTR Verification.
