Note :- (3) The Short List is prepared based on the details furnished by the candidate in the application and subsequent claims made will not be entertained at any stage.

Note :- (4) 14(Fourteen) candidates who have secured top most marks in the OMR Examination are included in the Main List of this Short List. The marks secured by the last candidate in the Main List is 71(Seventy One (point) zero ). For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes, and Economically Weaker Section, necessary Supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (5) Candidates included in the Short List should present and produce in person the original documents for One Time Verification. Date, time and Venue of OTR Verification and Interview of candidates included in this Short List will be intimated in due course.

Note:- (6) The register number of candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the short list without further notice.

Note :- (7) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (8) Candidates belonging to Other Backward Classes included in the list are required to produce Non Creamy Layer Certificate as per G.O(P)No.81/09/SC/ST/DD dated 26-09-2009, candidates belonging to SC/ST are required to produce Community Certificate in Form III or Digitally Signed issued by the Revenue Authority not below the rank of Tahsildar and candidates belonging to Economically Weaker Sections are required to produce EWS Certificate issued by the concerned authority at the time of OTR Verification.

Note:- (9) Copy of answer scripts of the OMR Test held on 06/01/2025 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidate whose Register Numbers are invalidated are advised to refer to Notification No : ER2A1/1/2025-KPSC Dated 15-03-2025.
