

Note :- (3) The Short List is prepared based on the details furnished by the candidate in the application and subsequent claims made will not be entertained at any stage.

Note :- (4) 12(Twelve) candidates who have secured top most marks in the Descriptive Examination are included in the Main List of this Short list. The marks secured by the last candidate in the Main List is 46.25 ( Forty Six(point) Two Five ). For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes, and Economicaly Weaker Section , necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (5) Candidates included in the Short List should present and produce in person the original documents for One Time Verification. Date,time and Venue of OTR Verification and interview of candidates included in this Short List will be intimated in due course.

Note :- (6) According to the existing procedure, Revaluation and Rechecking of answer scripts of Descriptive Test are not allowed. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (7) Candidates belonging to Other Backward Classes are required to produce Non Creamy Layer Certificate as per GO(P) No.81/09/SCSTDD dated 26.09.2009 or that obtained through e-district portal in the format prescribed in GO(Rt) No.3942/2018/RD dated 24.09.2018 and SC/ST candidates are required to produce Community Certificate issued by the Revenue authority and candidates who claim EWS reservation are required to produce EWS certificate vide GO(MS) No.2/2020/P&ARD dated 12.02.2020 along with other documents mentioned,at the time of OTR verification of original documents.

Note :- 8) The Register number of those candidates who do not produce the required documents within the prescribed time limit and whose applications found otherwise defective will be deleted from the Short List without further notice.

Note :- (9) Scanned image of Tabulation sheet and answer sheet of the Descriptive Test held on 06.12.2023 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No Answer script is invalidated for this post vide Notification number ER2A1/2/2024-KPSC dated 08/01/2025.
