

Note :- (6) For Online Examination , rechecking and revaluation are not allowed but print out of the answer sheets will be issued to those candidates who apply for it by remitting the prescribed fee after the publication of the Ranked List.Detailed instructions will be furnished in the Ranked list to be published for the post.
