Note :- (2) 10 (Ten) Candidates who have secured top most marks in the Online examination held on **11.03.2025** are included in the Main List of this Short List. The marks secured by the last candidate in the Main List is **33 (Thirty Three)**. For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Sheduled Tribes, Other Backward Classes and Economically Weaker Sections, necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes. **As sufficient number of candidates are available in the List I, List II & III are not prepared for the post.**

Note :- (3) Candidates included in the Short List should present and produce in person the original documents for One Time Verification. **Date, Time and Venue of One Time Verification, Physical Measurement and Interview will be published in due course.**

Note :- (4) Candidates belonging to SC/ST Community included in the Short List are required to produce Community Certificate issued by the Revenue authority and candidates belonging to Other Backward Classes included in the Short List are required to produce Non-Creamy Layer Certificate issued by the Revenue authority and candidates belonging to EWS category are required to produce EWS certificate issued by the Revenue Authority at the time of One Time Verification.

Note :- (5) For Online Examination, rechecking and revaluation are not allowed but printout of answer sheets will be issued to those candidates who apply for it by remitting the prescribed fee after the publication of Ranked List. Detailed instructions will be furnished in the Ranked List to be published for the post.
