**NOTE (1) :-** The rules 14 to 17 of part II of the Kerala State and subordinate Service Rules, 1958 are not applicable to appointment By Transfer Recruitment. As the advice for appointment depends on the occurrence of vacancies there is no guarantee that all the candidates included in the Ranked List will secure appointment. If sufficient number of candidates are not available to fill up the 10% reservation quota mentioned above, such vacancies will be filled up by candidates included in the ranked list prepared for Open Quota. In case candidates included in the Ranked List prepared for recruitment By Transfer could not secure appointment before the expiry of the Ranked List, the names of such candidates will be included at the top of the new ranked list of the low paid employees drawn up by the Commission subsequently in the same order and they will be advised for appointment accordingly vide G.O.(P) No. 39/89/ P & ARD dated 08.12.1989.

**NOTE (2) :-**For Online Examination, rechecking and revaluation are not allowed. Candidates who wish to obtain a printout of their Answer Sheets relating to this selection shall submit an online application through their One Time Registration profile from the official website of the Commission, [www.keralapsc.gov.in](http://www.keralapsc.gov.in), by remitting the prescribed fee of **Rs. 335/-** (Rupees three hundred and thirty-five) via e-payment mode available in the portal. A period of **15 (fifteen)** days to apply for the printout of Answer Sheet will be allowed to candidates with effect from the date on which the Ranked List is uploaded on the Commission's website (ie on or before **29.05.2025**). Applications submitted in any other manner (i.e., via email/Tappal/Direct) will not be considered. A copy of the Answer Sheet will be issued only once to a candidate.

**NOTE (3) :-**The candidate who wish to relinquish their claim for advice from the Ranked list shall submit an application in the format prescribed by the commission to The District Officer, Kerala Public Service Commission, District Office, Palakkad - 678001. The format is available in the official Website of the Commission. The request for relinquishment in respect of those who do not submit the relinquishment application in the prescribed format will not be honoured under any circumstances. The request for relinquishment in the prescribed format should be duly attested by a Gazetted Officer of State/ Central Government with Signature, Name, Designation and Office Seal along with a notarized affidavit and a self attested copy of an ID proof bearing photograph as enlisted in the general conditions. The request for relinquishment received within 15 days from the date of publication of Ranked List in the official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalization of the Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advise.

**NOTE (4) :-**Since a common Online Test with common candidates was conducted for this post, the marks awarded to candidates included in this Ranked List and mark of Online test relating to all candidates appeared for the test will be published only after the publication of entire Ranked Lists (including NCA Notifications) which will be finalized on the basis of the common test. The printout of the answer scripts will be issued only after the publication of the Ranked lists for all the posts.
