NOTE (1) :-In case candidates included in this Ranked List could not secure appointment before the expiry of the Ranked List, The names of such candidates will be included at the top of the new Ranked List of the low paid employees drawn up by the Commission subsequently in the same order and they will be advised for appointment accordingly vide G.O.(P)No.39/89/P&ARD dated 08.12.1989.The principles of rules of reservation and rotation prescribed in Rule 14 to 17 part II of the KS & SSR 1958 will not be applicable for this notification.

NOTE (2) :-For Online examination rechecking and revaluation are not allowed but printout of answer sheet will be issued to those who apply for it by remitting the prescribed fee. Candidates who wish to obtain a printout of their answer sheet relating to this selection shall submit online application through their One Time Registration profile from the official website of the Commission, **www.keralapsc.gov.in** by remitting the prescribed fee of Rs.335 (Rupees ThreeHundred And Thirty Five Only) via e-payment mode available in the portal. A period of 15(Fifteen) days time to apply for print out of answer sheet will be allowed to candidates with effect from the date on which the Ranked list is uploaded in the website of the Commission . Application submitted in any other manner(ie. Via email /tappal/direct) will not be considered. A copy of an answer sheet will be issued only once to a candidate.

NOTE (3) :- The candidates who wish to relinquish their claim for advice from the Ranked List shall submit an Application in the format prescribed by the Commission addressed to The District Officer, Kerala Public Service Commission, District Office, Thiruvananthapuram-695004. The format is available in the official website of the Commission. The request for relinquishment in respect of those who do not submit the Relinquishment Application in the format prescribed by the Commission will not be honoured under any circumstances. The request for relinquishment in the prescribed format should be duly attested by a Gazetted Officer of State/ Central Government with signature, name,designation and office seal along with a notarized affidavit and a self attested copy of an ID proof bearing photograph as enlisted in the General Conditions. The request for relinquishment, along with the original of notarized affidavit and self attested copy of an ID proof received within 15 days from the date of publication of Ranked List in the official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalization of the Ranked List. In the case of the requisitions of vacancies received after the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition based on which he/she is to be advised.

NOTE (4) :-Since a common Online Test with common candidates was conducted for this post, the marks awarded to candidates included in this Ranked List and mark of Online test relating to all candidates appeared for the test will be published only after the publication of entire Ranked Lists (including NCA Notifications) which will be on the basis of the common test.
