Note :- (7) Candidates belonging to Other Backward Classes are required to produce Non Creamy Layer Certificate as per GO(P) No.81/09/SCSTDD dated 28.06.2009 or that obtained through e-district portal in the format prescribed in GO(Rt) No.3942/2018/RD dated 24.09.2018 and SC/ST candidates are required to produce Community Certificate issued by the Revenue authority and candidates who claim EWS reservation are required to produce EWS certificate vide GO(MS) No. 2/2020/P&ARD dated 12.02.2020 along with other documents mentioned, at the time of OTR verification of original documents.

Note :- (8) Scanned image and Tabulation sheet of answer scripts of the Descriptive Test held on 06/12/2023 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
