Note :- (3) 57 (Fifty Seven) candidates who have secured top most marks in the OMR Examination are included in the Main List of this Short List. The marks secured by the last candidate in the Main list is 57.33 (Fifty seven (point) three three).For the purpose of satisfying the rules of reservation of appointment to Sheduled Castes, Scheduled Tribes, Other Backward classes (and other reserved categories if any) necessary supplementary list is prepared by including sufficient number of candidates from lower mark ranges in the order of merit of the candidates belonging to suchclasses.

Note :- (4)Candidates included in the Short List should present and produce in person the original documents for One Time Verification. Date, time and Venue of OTR Verification and interview of candidates included in this Short List will be intimated in due course.

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6)Candidates included in the Short List who are eligible for reservation for Other Backward Classes are required to produce Non Creamy Layer Certificate as per G.O(P)No.81/09/SCSTDD dated 26.09.2009 or that obtained through e-district Portal in the format prescribed in G.O(Rt) No 3942/2018/RD dated 24.09.2018 and SC/ST candidates are required to produce Community Certificate issued by the Revenue Authority not below the rank of Tahsildar and candidates who claim EWS reservation are required to produce EWS Certificate issued by the Revenue Authority along with other documents at the time of OTR verification of original documents

Note :- (7) Copy of answer scripts of the OMR Test held on **08-08-2024** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No : : ER4B2/12/2024-KPSC Dated on 27/01/2025.
