

Note :- (6) Candidates included in the Short List who belong to Other Backward Classes are required to produce Non-Creamy Layer Certificate issued by Village Officer as per GO(P) No.81/09/SCSTDD dated. 26.09.2009, SC/STCandidates are required to produce Community Certificate issued under Rule 4 of Kerala (SC/ST) Regulations of issue of Community Certificate Rules 2002 by the Revenue authority not below the Rank of Tahasildar and candidates claiming reservation under EWS category are required to produce EWS Certificate issued by Village Officer as perGO(Ms) No.23/2022/P&ARD dated 04.10.2022 along with other documents at the time of OTR Verification.
