Note:- (2) The list has been prepared by including the number of candidates who have secured top marks in the OMR Test.

Note :- (3) The Probability list has been prepared based on the details furnished by the candidate in the application and subsequent claim will not be entertained at any stage. If any of the documents produced by any candidate is found defective, the Commission reserves the right for rejection of his candidature at any stage of selection as per rule.

Note :- (4) **63 (Sixty Three)** candidates who have secured top marks in the OMR Examination are included in the Main List of this Probability List. The mark secured by the last candidate in the Main list is **78.33 (seventy eight (point) three three)** Marks. For the purpose of satisfying the rules of reservation of appointment to Scheduled Caste, Scheduled Tribes, Other Backward Classes and Economically Weaker Section (and other reserved categories if any) necessary Supplementary List is prepared by including sufficient number of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note:- (5) Candidates included in the Probability List should present and produce in person the original documents for One Time Verification. **Date, time and Venue of OTR Verification will be published shortly.**

Note:- (6) Candidates belonging to Other Backward Classes included in the Probability List are required to produce Non Creamy Layer Certificate as per GO(P)No.81/09/SC/STDD dated. 26.09.2009 or that obtained through e-district portal in the format prescribed in GO(Rt) No.3942/2018/RD dated, 24.09.2018 and SC/ST Candidates are required to produce Community Certificate (Form III / Digitally Signed) issued by the Revenue Authority not below the Rank of Tahsildar and candidates claiming reservation under EWS category are required to produce EWS Certificate vide GO(Ms) No.2/2020/P&ARD dated 12.02.2020 issued by the Revenue Authority along with other documents at the time of OTR Verification of original documents. According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (7) The Register number of those candidates who do not produce the required documents within the prescribed time limit and whose applications found otherwise defective will be deleted from the Probability List without further notice.

Note :- (8) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (9) Copy of answer scripts of the OMR Test held on 07-01-2025 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No candidates are invalidated for the post.
