- **NOTE (1)**:- The Ranked List will be in force till the publication of a new Ranked List after the expiry of a minimum period of one year or till the expiry of three years whichever is earlier. A period of 15 (Fifteen) days time to apply for rechecking of Answer Scripts will be allowed to candidates with effect from the date on which the Ranked list is uploaded in the website of the Commission. i.e. on or before 17/06/2025 The candidates can avail only one chance after the approval of Ranked List. Rechecking of invalidated answer scripts due to any defects will not be considered. Fee once remitted will not be refunded. Applications submitted through email/by post/in person will not be considered.
- **NOTE (3)**:-Candidates who wish to obtain a photocopy of their OMR Answer Sheets (Part A & Part B) relating to this selection shall submit online application through their One Time Registration profile from the official website www.keralapsc.gov.in by remitting the prescribed fee of Rs. 335/- (Rupees Three Hundred and thirty five only) via epayment mode available in the portal. A period of 15 (Fifteen) days time to apply for photocopy of OMR sheets will be allowed to candidates with effect from the date on which the Ranked List is uploaded in the website of the Commission ie. on or before 17/06/2025 .A copy of an answer sheet will be issued only once to a candidate. Copies of OMR sheets invalidated due to any defect will not be issued. Candidate Applications submitted in any other manner will not be considered.
- **NOTE (4)**:- The entries put in column (8) are based on the Communities specified by the candidate in their Application forms and proved by them with necessary documents. The candidate whose Communities have not been correctly noted in the Ranked List as proved by them in their Application should intimate the fact to the Deputy Secretary (Examinations) -I Kerala Public Service Commission, Thiruvananthapuram 695004 within one month from the Date of publication of the Ranked List to get the benefit of Reservation to which they are entitled to. In the absence of timely information regarding discrepancies if any, the candidate will be advised as incorporated in the Ranked List.
- **NOTE (5)**:- Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/ Central Government with Signature, Name, Designation and Office Seal along with a notarized affidavit and a self attested copy of an ID proof bearing photograph as enlisted in the general conditions.
