

NOTIFICATION

The following is the list of candidates for selection to the post of CLERK (PART II - RECRUITMENT BY TRANSFER) (FROM EX-SERVICEMEN ONLY)(Cat No:334/2024) on Rs.26,500-60,700/- in the NCC/SAINIK WELFARE DEPARTMENT IN KOTTAYAM DISTRICT, found suitable by the Commission and arranged in the order of merit based on the Common Online Examination held on 11/03/2025. This Ranked List is brought into force with effect from 27/05/2025.



NOTE (1):- Since a common Online Test with common candidates was conducted for this post, the marks awarded to candidates included in this Ranked LIst and mark of Online test relating to all candidates appeared for the test will be published only after the publication of entire Ranked Lists(including NCA Notifications)which will be finalised on the basis of the common test.

NOTE (2):- .The rules regarding the reservation of appointment contemplated in Rule 14 to 17 in Part II of the KS&SSR are not applicable to Recruitment By Transfer.

NOTE (3):-The Ranked List will be in force till the publication of a new ranked list after the expiry of a minimum period of one year or till the expiry of three years which ever is earlier. Candidates from the Ranked List will be advised for appointment in accordance with the rules and orders regarding reservation and rotation as amended from time to time, if applicable, against vacancies reported to the Commission during the Pendency of the Ranked List. As the advice for appointment depends on the occurrence of vacancies, there is no guarantee that all the candidates included in the Ranked List will secure appointment. The candidates remaining in the Ranked List at the time of cancellation will have no claim at all for appointment on the basis of inclusion of their names in the Ranked List.

NOTE (4):- For Online Examination rechecking and revaluation are not allowed. Candidates who wish to obtain a printout of their Answer sheets relating to this selection shall submit online application through their One Time Registration profile from the official website of the Commission, www.keralapsc.gov.in by remitting the prescribed fee of Rs. 335/-(Rupees Three Hundred and Thirty Five Only) via e-payment mode available in the portal. A period of 15 (Fifteen) days time to apply for print out of answer sheet will be allowed to candidates with effect from the date on which the Ranked List is uploaded in the website of the Commission (ie on or before 15/06/2025). Application submitted in any other manner (i.e. via email/Tappal/Direct) will not be considered. Print out of the answer sheet which is not their own, and legal proceedings will be initiated against those who do so.

NOTE (5):- Any candidate can relinquish his/her right for appointment in writing addressed to The District Officer, Kerala Public Service Commission District Office, Muttambalam P O, Kottayam, 686004 in the format prescribed by the Commission duly attested by a Gazetted Officer of State/ Central Government with Signature, Name, Designation and Office Seal along with a notarized affidavit and a self attested copy of an ID proof bearing photograph as enlisted in the general conditions. "The Candidates who wish to relinquish their claim for advice from the Ranked list shall submit an Application in the format prescribed by the Commission. The format is available in the official website of the Commission. The request for relinquishment in respect of those who do not submit the Relinquishment Application in the format prescribed by the Commission will not be honoured under any Circumstances". The request for relinquishment received within 15 days from the date of publication of Ranked List in the official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalization of the Ranked List. In the case of the requisition of vacancies received after the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised.
