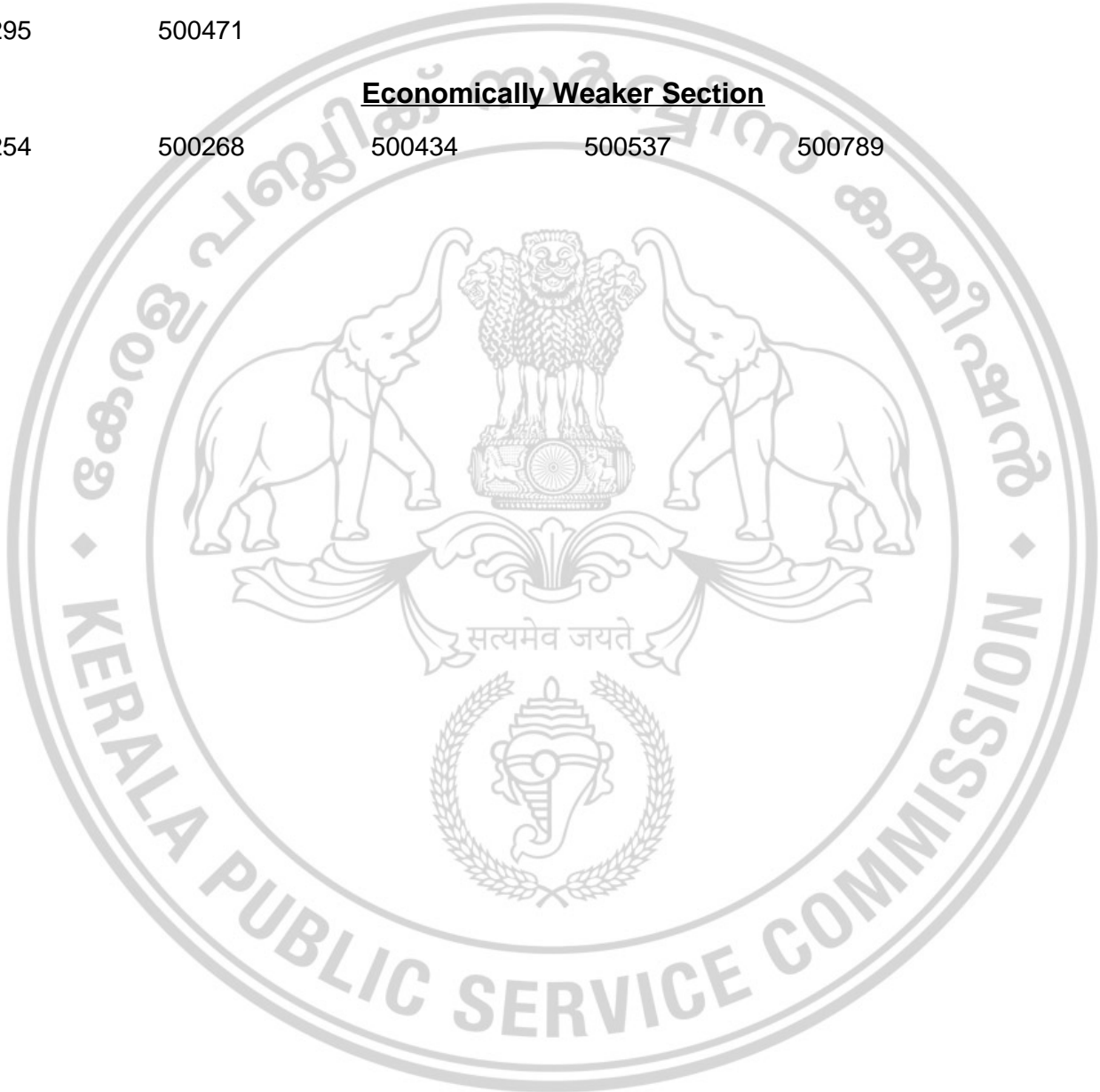

Note :- (5) According to the existing procedure, Revaluation and Rechecking of answer scripts of Descriptive Test are not allowed. Detailed instructions will be published in the Ranked List notification to be published for the post.

Note :- (6) Candidates included in the Short List are required to produce Non Creamy Layer Certificate as per GO(P) No.81/09/SC/STDD dated. 26.09.2009, SC/ST Candidates are required to produce Community Certificate issued under Rule 4 of Kerala (SC/ST) Regulations of issue of Community Certificate Rules 2002 by the Revenue authority not below the Rank of Tahsildar and candidates claiming reservation under EWS category are required to produce EWS Certificate issued by Village Officer as per G.O.(Ms) No.2/2020/P&ARD dated 12.02.2020 along with other documents at the time of OTR Verification.

Note :- (7) Scanned image of Tabulation sheet and answer scripts of the Descriptive Test held on 25.10.2023 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
