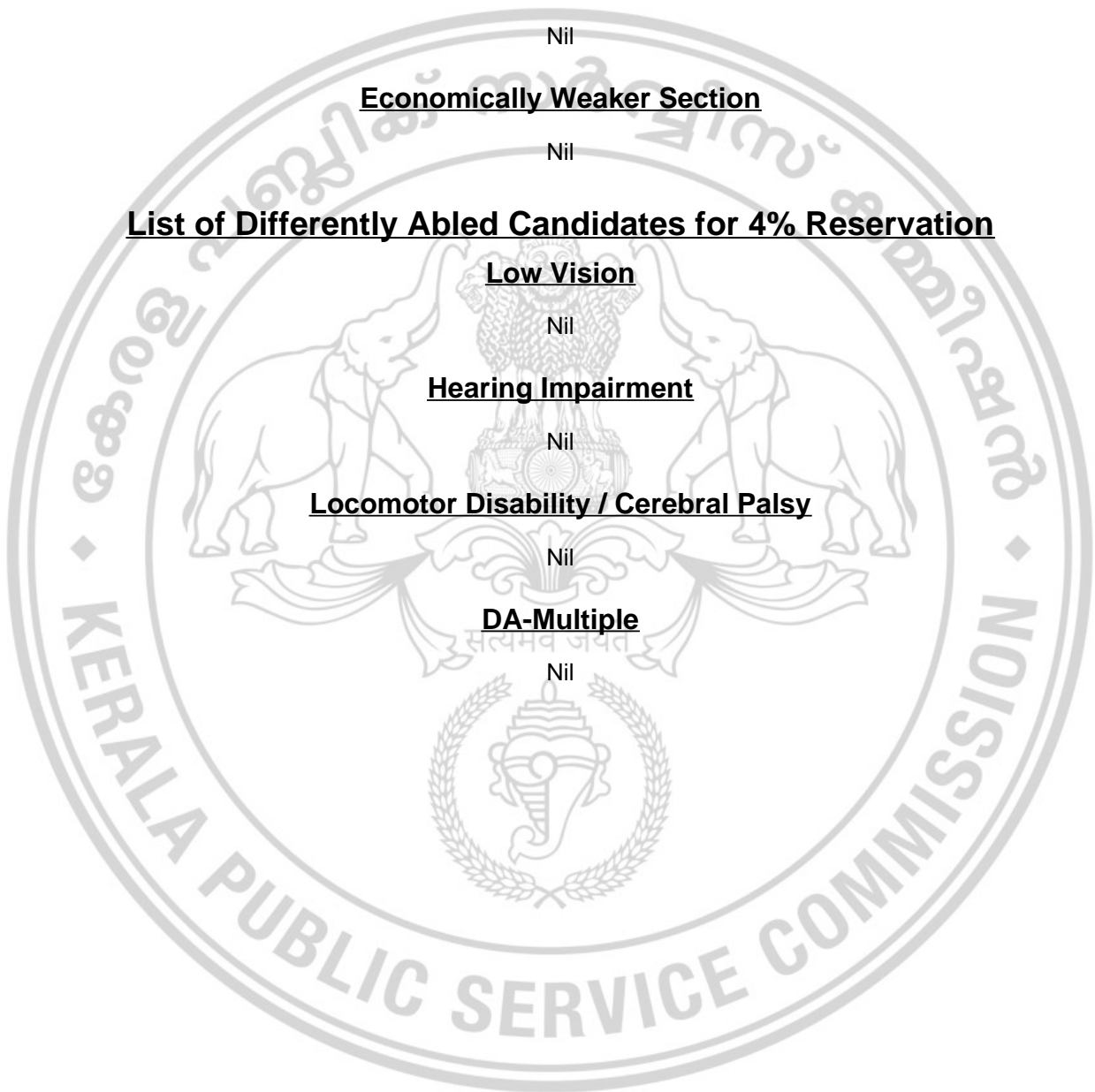

Note :- (3) 10 (Ten) candidates who have secured topmost marks in the Descriptive examination are included in the Main List of this Short list. The Marks secured by the last candidate in the Main List is 37.50 (Thirty Seven (point) five zero). For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes (and other reserved categories if any) necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) Candidates included in the Short List should present and produce in person the original documents for One Time Verification and Interview. **Date, time and Venue of OTR Verification and Interview will be intimated in due course.**

Note :- (5) The register number of those candidates who do not produce the required documents within the prescribed time limit and whose applications found otherwise defective will be deleted from the Short list without further notice.

Note :- (6) Candidates included in the Short List are required to produce Non Creamy Layer Certificate as per G.O.(P) No.81/09/SC/STDD dated. 26.09.2009 and SC/ST Candidates are required to produce Community Certificate issued under Rule 4 of Kerala (SC/ST) Regulations of issue of Community Certificate Rules 2002 by the Revenue authority not below the Rank of Tahsildar, along with other documents at the time of OTR Verification.

Note :- (7) According to the existing procedure, Revaluation and Rechecking of answer scripts of Descriptive Test are not allowed. Scanned image of Tabulation sheet and answer scripts of the Descriptive Test held on 11.02.2025 will be issued to those candidates who apply for the same, remitting the prescribed fee after approval of the Ranked List. Detailed instructions will be published in the Ranked List notification to be published for the post. No answer script is invalidated for this post vide Invalidation Notification No : ER4-3/2/2025-KPSC Dtd 31.05.2025.
