The candidates who have scored 47.25 (Forty Seven (point) Two Five) marks and above are included in Part I and candidates who have scored 49.5 (Forty Nine (point) Five) marks and above are included in Part II of the Short List

Note :- (4) Candidates included in the Short List should present and produce in person the original documents for One Time Verification. **Date,time and Venue of OTR Verification will be published shortly.**

Note :- (5) The register number of candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the short list without further notice.

Note :- (6) According to the existing procedure, Revaluation and Rechecking of answer scripts of Descriptive Test are not allowed. Detailed instructions will be published in the Ranked List notification to be published for the post.
