Note :- (6) Candidates included in the Short List who belongs to Other Backward Classes are required to produce Non Creamy Layer Certificate as per G.O.(P) No.81/09/SC/STDD dated. 26.09.2009 , candidates belonging to SC/ST are required to produce Community Certificate issued under Rule 4 of Kerala (SC/ST) Regulations of issue of Community Certificate Rules 2002 by the Revenue authority not below the Rank of Tahsildar and candidates belonging to Economicaly Weaker Section are required to produce EWS Certificate issued by the Village Officer as per G.O.(Ms) No.2/2020/P&ARD dated 12.02.2020 along with other documents at the time of OTR Verification.
