

Note :- (1) Inclusion of Register Numbers in this list is purely provisional subject to scrutiny and admission of application on absolute basis. Inclusion of Register numbers in the Short List does not confer any right on the candidate for inclusion in the Ranked List.

Note :- (2) The list has been prepared by including the number of candidates who have secured top marks in the **Descriptive Test** held on **11-10-2023**. Subsequent claims made will not be entertained at any stage of selection.

Note :- (3) **25 (Twenty Five)** candidates who have secured topmost marks in the Descriptive examination are included in the Main List of the Short list. The marks secured by the last candidate in the Main List is **47.75 (forty seven (point) seven five)**. For the purpose of satisfying rules of reselection of appointments to Scheduled Castes, Scheduled Tribes, Other Backward Classes and EWS, necessary supplementary list is prepared by including sufficient number of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) Candidates included in the Short List should present and produce in person the original documents for One Time Verification. **Date, time and Venue of OTR Verification and Interview will be published shortly.**

Note :- (5) The register number of candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the Short List without further notice.

Note :- (6) According to the existing procedure, Revaluation and Rechecking of answer scripts are not allowed. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (7) Candidates belonging to Other Backward Classes are required to produce Non Creamy Layer Certificate as per GO(P) No.81/09/SCSTDD dated 28.06.2009 or that obtained through e-district portal in the format prescribed in GO(Rt) No.3942/2018/RD dated 24.09.2018 and SC/ST candidates are required to produce Community Certificate issued by the Revenue authority and candidates who claim EWS reservation are required to produce EWS certificate vide GO(MS) No. 2/2020/P&ARD dated 12.02.2020 along with other documents mentioned, at the time of OTR verification of original documents.

Note :- (8) Scanned image of Tabulation sheet and answer scripts of the Descriptive examination held on 11-10-2023 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answer scripts are invalidated vide Notification No : OSM-3/3/2025-KPSC dated 25/06/2025.
