The marks secured by the last candidate in the Main List is 72.33 ( Seventy Two point Three Three ) . For the purpose of satisfying the rules of reservation of appointment to Scheduled Caste, Scheduled Tribes, Other Backward Classes and other reserved categories (if any) necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note:- (4) Candidates included in the Probability list should present and produce in person the original documents for One Time Verification. Date, Time and Venue of OTR Verification will be published in due course.

Note:- (5) The register number of those candidates who do not produce the required documents within the prescribed time limit and whose applications found otherwise defective will be rejected.

Note :- (6) Candidates belonging to Other Backward Classes included in this list are required to produce Non Creamy Layer Certificate as per G.O.(P) No.81/2009/SC/STDD dated 26.09.2009, candidates belonging to SC/ST communities are required to produce Community Certificate (Form III or Digitally Signed) issued by the Revenue Authority not below the rank of Tahsildar and candidates who claim EWS reservation are required to produce EWS Certificate vide G.O(MS) No.2/2020 P&ARD dated 12.02.2020 issued by the concerned authority at the time of One Time Verification

Note :- (7) For Online Examination, rechecking and revaluation are not allowed but printout of answer sheets will be issued to those candidates who apply for it by remitting the prescribed fee after the publication of Ranked List. Detailed instructions will be furnished in the Ranked List to be published for the post
