The mark secured by the last candidate in the Main list is 52.25 ( fifty two (point) two five ) .For the purpose of satisfying the rules of reservation of Appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes and Differently Abled , necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes

Note:- (5) Candidates included in the Probability List should present and produce in person the original documents for One Time Verification. Date, time and Venue of OTR Verification will be intimated through SMS and Profile message.

Note:- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (7) Candidates belonging to the Other Backward Classes included in the Short List are required to produce a Non Creamy Layer Certificate as per G.O.(P) No.81/2009/SCSTDD dated:26.09.2009, SC/ST candidates are required to produce a Community Certificate either in Form III or digitally signed certificate issued by Revenue Authority not below the rank of a Tahasildar and candidates who claim EWS reservation are required to produce EWS Certificate vide GO(Ms) No. 23/2022/P&ARD Dtd.04.10.2022 issued by the Revenue Authority along with other documents at the time of OTR verification

Note :- (8) Scanned images and Tabulation sheet of Descriptive Test held on 21-08-2024 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No Candidates are invalidated as per Notification No :ER16-2/14/2024-KPSC dtd:29.01.2025 .
