Note 1.Inclusion of register numbers in this list is purely provisional. This inclusion does not confer any right on the candidate for inclusion in the Ranked list to be prepared on the basis of the Main Examination.

Note 2. The register number of candidates who have secured top mark in the OMR Test (Preliminary Examination) are included in the list.

Note 3. The candidates who have secured 29 (Twenty Nine) Marks and above in the Preliminary OMR test are included in the eligibility list. The Candidates included in the list shall have to prove their claim by producing Non Creamy Layer Certificate at the time of One Time Verification, if they are included in the list to be published after the final examinations. Note 6.According to the existing procedure, revaluation of Answer Script is not allowed. But Answer Scripts will be rechecked if the candidates apply for through their one time registration profile by remitting the prescribed fee of Rs.85/-(Rupees Eighty Five Only). The fee can be remitted by e-payment through the portal. Applications submitted in any other manner will not be considered. A period of 15 days (Fifteen days) time to apply for rechecking of answer scripts will be allowed to candidates with effect from the date on which the eligibility list is uploaded in the website of the commission(ie, on or before 04.08.2025). The candidates can avail only one chance for rechecking after the Approval of Eligibility List within the time limit fixed above. Rechecking of answer scripts invalidated due to any defects will not be considered. Application for Rechecking received after the stipulated time will not be entertained and Fee once remitted will not be refunded.
